Subject : Inter-Circle Transfer of Inspectors of Posts under Rule 38 of P&T Manual Vol. IV-Reg.

Respected Madam,

I am enclosing herewith copy of application dated 18/12/2012 received from **J Balaji Inspector Posts, 'W' IV Sub Division, RMS "W" Division, Surat 395003** seeking transfer under Rule 38 of P&T Manual Vol. IV from Gujrat Circle to Tamil Nadu Circle.

The applicant is a surplus candidate of Inspector Posts examination 2008 and allotted to Gujarat Circle. He has already applied for Inter-Circle transfer under Rule 38 to Directorate and copies endorsed to CPMsG Tamil Nadu and Gujarat Circles. The applicant has applied for Inter-Circle on family ground and on completion of 2 years service outside the Home Circle. He has already completed his probation period successfully. He has joined Inspectors Posts cadre on 18/12/2010 in Anleshwar Sub division. It is learnt that there are sufficient vacancies in Tamil Nadu Circle to accommodate official in IP cadre. Gujarat circle there is no shortage of Inspector Posts, new batch of IPs is waiting for posting order.

This Association would like to bring to your kind notice that, **Directorate vide their memo No. A-141-177/2009-SPB-II dated 14th December, 2010 has issued guidelines for Inter-Circle transfer of Inspectors of Posts under Rule 38 of P&T Manual Vol. IV.** In the said memo it has stated that minimum service limit is 3 years for surplus qualified IPs and CPMG of the Circle where the IPs are working would be competent to permit such transfer in consultation with the CPMG of the Circle where the transfer is sought for by the individual.

This Association would like to state that, the CPMG, Gujrat Circle should take a considerate view in consultation with CPMG, Tamil Nadu Circle while considering the request of above named official for transfer to his Home Circle under Rule 38 of P&T Manual Vol. IV.

In view of the above submissions, it is requested to kindly arrange to issue necessary instructions / directions to CPMG Gujarat Circle to issue Inter-Circle transfer order of above named official immediately.

Hoping for a favourable action and line in reply is requested.
