25 Years Strong: Honoring the Businesses That Built Our Region

Danville, VA – In 2026, the Danville Pittsylvania Chamber of Commerce celebrates a milestone that reflects vision, collaboration, and a shared commitment to regional success - 25 years as a Regional Chamber.

The Chamber, as we know it today, was officially formed on July 1, 2001, following the merger of the former Danville Area Chamber of Commerce and the Pittsylvania County Chamber of Commerce.

This historic decision did not happen overnight. Merger discussions began in May 2000, after years of collaboration between the two organizations through joint programs and a shared membership base. Recognizing the opportunity to better serve businesses across the region, members of both Chambers overwhelmingly voted in May 2001 to unite as one.

With that vote, a new chapter began - one rooted in the belief that regional collaboration would create stronger outcomes than operating separately.

The newly formed Chamber launched under the leadership of its first co-chairs, Gene Hayes and Linda Rhue, alongside a diverse and dedicated board representing industries across the region. Their collective leadership laid the foundation for what would become a powerful voice for business in Danville and Pittsylvania County.

The merger also reflected a thoughtful commitment to serving the entire region. The main office was established in Blairs, with a continued presence in Danville and the addition of a satellite office in Gretna - ensuring accessibility and engagement across both communities.

While the Regional Chamber was formed in 2001, its roots run much deeper.

The Danville Chamber traces its origins back to 1894, when it was founded as the Commercial Association with a mission to promote the business and general interests of the city. Meanwhile, the Pittsylvania County Chamber was established in 1981 through the consolidation of the Chatham and Gretna Chambers, growing rapidly to support businesses throughout the county.

Together, these organizations brought more than a century of leadership, advocacy, and community focus into a single, unified Chamber.

Honoring 25-Year Legacy Members
