



CLOTHING RENTALS: TERMS & CONDITIONS

I. DISCLAIMERS

These Terms & Conditions apply to the AMIIBARI website located at www.amiibari.com, and all associated websites or social media profiles linked to www.amiibari.com. By filling out and submitting the Clothing Rental Form (collectively, the "form") on pages 2, 3, and 4 of this document, you (collectively, the "renter") agree to these Terms & Conditions.

II. RESPONSIBILITIES

Regarding the submission and, afterward, the approval of the form on pages 2 and 3 of this document:

1. Prospective renters (located in the U.S./Canada ONLY) must submit this document at least 2 weeks (U.S.) or 3 weeks (Canada) in advance from the estimated date(s) of usage.
2. Tracked shipping to the renter will be paid by AMIIBARI. Shipping takes approx. 1 week.
3. Return shipping, postage, and incurred customs fees (if applicable) will be paid by the renter.
4. AMIIBARI will send the renter an invoice through PayPal detailing the following information:
 - a. **A SAFETY DEPOSIT OF 100% OF THE RETAIL PRICE of all rented pieces is required.** See page 5 for a list of available pieces and their retail prices.
 - b. The safety deposit will be paid through the PayPal invoice (AMIIBARI takes any credit/debit cards, Venmo, or PayPal).
 - c. The 100% safety deposit must be paid within 1 week of receiving the invoice.
 - d. **80% of the safety deposit will be refunded to the renter** via PayPal after AMIIBARI receives all rented pieces back by the "estimated return date" (see page 2). For the renter to receive 80% of their deposit back, all rented pieces must be returned in a timely manner and in excellent condition.
 - e. **20% of the safety deposit is NON-REFUNDABLE** and is kept by AMIIBARI. This 20% covers the cost of shipping and labor and serves as the "rental fee."
5. All rented pieces must be returned cleaned and in excellent condition by the date chosen in collaboration by both the renter and AMIIBARI ("estimated return date," see page 2). If this is not the case, no refunds will be given and the renter forfeits their entire 100% safety deposit.
6. If rented pieces are returned more than 1 week after the "estimated return date" (see page 2), if the package is lost or damaged, or if there is disingenuous possession of any of the pieces (keeping rented pieces for oneself without prior notice), etc., no refunds will be given and the renter forfeits their entire 100% safety deposit. Additionally, a lost package claim may be completed by either AMIIBARI or the renter via their respective mail centers.
7. If rented pieces are stolen, lost, or damaged beyond repair while in the renter's possession, no refunds will be given and the renter forfeits their entire 100% safety deposit.
8. The renter will be blacklisted from any/all future rentals if these Terms & Conditions are violated.

III. LEGAL NOTICE

Failure to comply with the Terms & Conditions as outlined above and in the form on pages 2, 3, and 4 of this document will result in the blacklisting of the renter from all future rentals with AMIIBARI. Should any contractual complications arise, please email info@amiibari.com with 'LEGAL' in the subject heading.

By filling out and submitting the form on pages 2, 3, and 4 of this document, the renter agrees that AMIIBARI, potentially without prior notice, may terminate the renter's access to clothing rentals and/or block any future access to www.amiibari.com if the renter has violated any/all of these Terms & Conditions. **The renter agrees that any violations of these Terms & Conditions will constitute an unlawful business practice which will cause irreparable damage to AMIIBARI; as such, legal action will be taken should this occur during or after the rental period.** The renter consents to AMIIBARI obtaining any monetary reparations (i.e. the entire 100% safety deposit) or other relief that AMIIBARI deems necessary in such circumstances.

V. ADDITIONAL TERMS

Please keep all pieces in excellent condition. If cleaning is needed, soak the pieces in lukewarm water, add a mild detergent or hand soap, then lay flat to air dry. Do not iron or steam. Store in a cool, dry place.

In the event that rented pieces are stolen, lost, or damaged beyond repair while in the renter's possession, no refunds will be given and the renter forfeits their entire 100% safety deposit. Failure to comply with all of these Terms & Conditions in the Clothing Rental Form will result in LEGAL ACTION.

BY CHECKING THESE BOXES, THE RENTER UNDERSTANDS & AGREES TO THE FOLLOWING:

SECURITY DEPOSIT

- ☐ After submission and approval of this form, AMIIBARI will send the renter an invoice through PayPal that states a summary of the information in this form. This invoice, which includes the 100% safety deposit, is to be paid within 1 week of receipt.
- ☐ The renter understands that 80% of the safety deposit will be refunded to them after AMIIBARI receives all rented pieces back NO LATER than 1 week after the "estimated return date."
- ☐ The renter understands that 20% of the safety deposit is NON-REFUNDABLE and acts as the "rental fee" which covers the cost of shipping and labor.

SHIPPING & RETURNS

- ☐ AMIIBARI will ship the rental pieces to the renter and cover all associated delivery fees.
- ☐ The renter understands that they will cover return shipping back to AMIIBARI no later than 1 week after the "estimated return date." The return shipping address will be disclosed following the approval of this form.
- ☐ All rented pieces must be returned in a timely manner (i.e. the "estimated return date") to ensure the satisfaction of both parties. The renter understands that they will forfeit their 100% security deposit should the rented pieces be returned later than 1 week after the "estimated return date."
- ☐ All rented pieces will be returned cleaned and in excellent condition no later than 1 week after the "estimated return date."

CREDITS

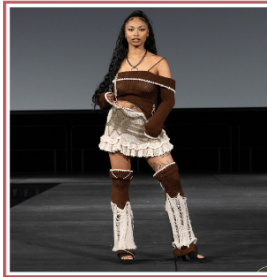
