Dog Registration: Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>.

Run Order: Trials will be run concurrently.

Move Ups & Downs: In accordance with NASDA rules, move ups and downs are permitted for teams who complete a title at the event. All changes must be made before the class in which the team wishes to compete begins.

Awards & Fun: Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Trial. New title rosettes will be awarded.

Bitches In Season: Bitches in season are eligible to compete. They must notify the Trial Secretary via email in advance of the trial. Bitches in season will run at the end of the event and must wear appropriate britches.

Venue/Parking:

Exhibitors will be crating in their vehicles. **CHAOS in the 417** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. No RV parking. Absolutely No alcohol or drug use allowed during the trials. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future Cit417 event.

- For Level 3, there will only be one set up. Handlers with multiple dogs in the same class at this level please take note.
- Entries are limited to 8-hours of judging per day. If this trial fills, a wait list will be created as needed.
- Pre-entry deadline is: 11:59pm on September 20th. Entry fees for entries made after the deadline increase by \$5/trial
- Cancellations must be made via email to the Trial Secretary
- Refunds will be mailed 7 days after the event
- No refund for cancellations after the closing date
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee
- Exhibitors are responsible for complete, accurate and legible information on their entry forms
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive

behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made

- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any cause beyond the control of CHAOS in the 417.
- All dogs must be on leash at all times except when competing
- Exhibitors are responsible for being in the staging area when it is their turn to run
- Please be courteous and pick up after your dog
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50 fee for any returned check or payment. Checks must be made payable to Heather Ferrier.
- CHAOS in the 417 reserves the right to refuse any entry without cause or explanation
- CHAOS in the 417 reserves the right to remove any individual for any reason from the premises. No refunds will be issued
- Please pack food and water for you and your dog.
- Absolutely No alcohol or drug use allowed during the trials. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future CHAOS in the 417 event.
