

App Blocker for Dopamine Detox Privacy Policy

Effective date: August 28, 2025

On August 28, 2025, we released an updated version of our Privacy Policy. Your continued use of App Blocker for Dopamine Detox means that you agree to this revised document. Please take a few minutes to read it carefully and understand how we handle your information.

Armen Danielian. (“we,” “us,” or “our”) values and respects your privacy. This Privacy Policy explains what information we collect, how we use it, with whom it may be shared, and what choices you have regarding your data when using the Flora mobile app, website, or related software (collectively, the “Service”). Terms used in this Privacy Policy have the same meaning as in our Terms of Service unless otherwise defined here.

By using our Service, you agree to the practices described in this Privacy Policy. If you have any questions about our privacy practices, please see the “Contact Us” section at the end of this document.

Information We Collect

We collect both personal information that can identify you (“Personal Information”) and non-identifying information.

Information you provide

When using the Service, you may provide information such as your name, email, phone number, contact list, and (if authorized) limited Facebook account data (e.g., friend list). If you chat with other users, we collect the chat content. If you contact us, we collect that communication. If you make transactions, we collect related payment details.

Log Data

We collect data your browser or device sends when you access the Service, such as IP address, browser type/version, pages visited, time/date of visit, session duration, mobile device details (OS, unique ID, mobile browser type), location data, and related statistics. Third-party services like Google Analytics may also collect such information to improve our functionality.

Cookies and Pixel Tags

We use cookies and pixel tags to simplify access, personalize your experience, and measure engagement. Cookies store preferences; pixel tags help us track usage patterns and ad performance.

Mobile Device IDs

On mobile, we may use device identifiers (e.g., Advertising IDs) instead of cookies to store preferences and track app usage.

How We Use Information

We may use your information to:

- Provide, personalize, and improve our Service
- Manage accounts, customer support, and requests
- Conduct research and analytics
- Communicate about services, offers, or updates
- Deliver tailored ads and content
- Track app usage and generate analytics
- Verify eligibility and manage contests or promotions
- Handle job applications
- Enforce our Terms of Service

Sharing of Information

We share your Personal Information only in limited cases:

- **With other users** (e.g., your profile name may be visible to friends)
- **With service providers** that perform tasks on our behalf (e.g., analytics, hosting)
- **With advertising partners** to deliver relevant ads
- **As required by law** (e.g., legal requests, subpoenas)
- **To enforce our rights** or investigate suspected fraud or abuse
- **During business transfers** (mergers, acquisitions, bankruptcy)

We may also share aggregated or anonymized information that cannot identify you personally.

Data Protection

We take reasonable security measures to protect your data from unauthorized access, disclosure, or misuse. However, no method of transmission or storage is 100% secure. Please exercise caution when sharing sensitive information online.

International Transfers

Our servers are based in the United States. By using our Service, you consent to the transfer of your data to the U.S., which may have different data protection laws than your country.

Your Choices

- **Account & Content:** You can review, update, or delete your information. Deleted content may be anonymized or hidden but not always fully removed.
- **Push Notifications:** Can be disabled in your device settings.
- **Location Services:** Can be enabled/disabled at any time in device settings.
- **Cookies:** You may disable cookies in your browser, though some features may not work properly.
- **Advertising IDs:** On iOS and Android, you can reset or limit ad tracking through system settings.
- **Communications:** You can unsubscribe from marketing emails or notifications at any time.

Children's Privacy

The Service is intended for users 13 years or older. We do not knowingly collect Personal Information from children under 13. Parents/guardians who believe their child has provided data should contact us, and we will delete such information. Additional safeguards may apply for minors aged 13–18.

Changes to This Policy

This Privacy Policy is effective as of August 28, 2025. We may update it from time to time. If significant changes are made, we will notify users via the Service or by posting a notice on our website. Continued use after changes indicates acceptance of the revised policy.
