## **Participant Registration Form & Waiver**

#### Liability Waiver & Assumption of Risk

I, \_\_\_\_\_\_understand and hereby agree that rowing and sculling include activities on land and on water (all of which are the "boating activities") that involved certain risks and dangers incidental thereto. Risks include, but are not limited to, injury from collision with another vessel or stationary objects and from the malfunctioning of equipment and injury or drowning, as a result of capsizing or being swamped by waves from passing vessels or adverse weather. Such risks are increased when the air or water temperature is low creating the risk of hypothermia. I also understand that the physical exertion of the boating activities, including the carrying of boats in and out of water, can result in injury or death. I further agree and acknowledge that:

I am responsible for being medically fit to engage in the activity of rowing and I confirm that I can swim and that I am in good health and do not suffer from a heart condition or other ailment that could be exacerbated by the exertion involved in rowing.

I agree to be bound by the rules established by the Host Site and/or Rowing Canada Aviron, and/ /or ROWONTARIO.

In spite of and fully understanding such risks and other risks not expressly stated I wish to participate in the boating activities at the Host Site and hereby assume all the risks of doing so. In consideration of the Host Site, Rowing Canada Aviron, and ROWONTARIO agreeing to allow me to participate in the boating activities accompanied or unaccompanied (meaning with or without a safety/coach boat), using the host site's public equipment as well as ROWONTARIO's equipment and permitting my use of club facilities, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree not to hold the Host Site, Rowing Canada Aviron, or ROWONTARIO, their directors, officers, employees, agents, coaches, independent contractors, subcontractors and representatives, all of whom are herein after referred to as the "Releasees", liable for my personal injury, death, and/or property loss, and;

TO WAIVE ANY AND ALL CLAIMS THAT I HAVE OR MAY HAVE IN THE FUTURE AGAINST THE RELEASEES AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage expense or injury including death that I may suffer or that my kin may suffer as a result of my participation in the boating activities, on land or on water, due to any cause whatsoever, including NEGLIGENCE, BREACH OF CONTRACT, BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE INCLUDING ANY DUTY OF CARE UNDER THE OCCUPIERS

LIABILITY ACT ON THE PART OF THE RELEASES AND FURTHER, INCLUDING FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD AND PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF THE BOATING ACTIVITIES REFERRED TO ABOVE.

I agree to hold harmless and to indemnify the Releasees from any and all liability for any property damage or personal injury to any third party resulting from my participation in the boating activities. I agree that this agreement shall be binding upon my heirs, next of kin, executors, administrators and assigns in the event of my death. In entering into this agreement, I am not relying on an oral or written representation or statements made by the Releasees with respect to the safety of the boating activities other than as set forth in this agreement. I have read and understood this agreement and I am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, and assigns may have against the Releasees.

# **Code of Conduct**

This code of conduct applies to all rowers and assisting volunteers in Tillsonburg Rowing Clubs programs

- 1. All rowers and assisting volunteers will respect the rights and feelings of others through words, actions and behaviors
- 2. All participants will perform to the best of their ability, so as to not hinder the progression of themselves or others
- 3. Rowers will behave appropriately and listen to the instruction of coaches and directions of the assisting volunteers
- 4. Failing to cooperate, insults or other hurtful acts that disrupt teaching and learning within the program will not be tolerated
- 5. Rowers and assisting volunteers will respect all property of others and of Tillsonburg Rowing Club
- 6. Rowers and assisting volunteers will arrive on time and be prepared for sessions

### Consequences:

Any serious acts of violence towards others or intentional vandalism of club property will result in immediate suspension from all club programs.

<u>First Offence:</u> a verbal warning will be issued, detailing the nature of the offence and expected appropriate behavior. Depending on the seriousness of the offence, a phone call to the parent/guardian may ensue for anyone under the age of 18. The warning will be documented by the Coach or Club Captain.

<u>Second Offence:</u> A written notice will be issued. Parents/Guardians for anyone under the age of 18 will receive the written notice as well.

<u>Third Offence:</u> The board will determine if immediate suspension from all Club programs or termination will be required.
