Things need to start moving along. The district is in statutory operating debt and needs to have a plan submitted to the state by the end of January on how it will work toward getting out of debt. **Negotiations update:** The negotiations team has presented our entire package, including financial proposals. There are more negotiation meetings scheduled before winter break. The negotiations team will be scheduling a backup negotiations committee meeting in January to update any progress. Givand A. Will be held on April 6, 2026, at 3:30 p.m. at the RFT office. Members interested in serving on the Budget Committee, contact Jacob\_Givand@rdale.org to fill the at-large positions (up to 4 positions available). James Stanton is the Chair of the Budget Meeting. This is a year of reauthorization. The vote will be held on Feb 10. Shannon will send out further information closer to the vote. We will be voting to continue authorizing funding from Minnesota Department of Education. A yes vote continues the stipend funding. If a NO vote were to prevail, Q Comp will go away, and Robbinsdale School District will NOT have an opportunity to bring it back at any time in the foreseeable future. \*\*\* A YES vote equates to: Q Comp Program with a stipend vs a NO vote equates to: no stipend funding with continued work and observation cycles, and no peer coaches. The proposed next year calendar was presented at the Monday, December 1, 2025 School Board Meeting, by Executive Director O'Hern. The RFT members on the calendar committee shared the wants and needs of our members. The following was ultimately presented to the school board.: The Wednesday before Thanksgiving will be a regular instructional day despite our efforts to change that. The reason shared by the administration for ending the school prior to Memorial Day was to make way for construction. What has been discussed is that there is not a levy in place or a plan voted on by the board beyond the 10-year facilities maintenance plan.

This proposed calendar was presented to the board. However, it will not come to a vote until the December 15th board meeting.

To access the proposed calendar, Start on the website with the "Discover tab - select 'School Board" - then "meetings, agendas, packets and minutes (green box on the right side of the page - and find the calendar attached to the agenda December 1, 7 pm Business Meeting under agenda item 8D.

The timeline is to be shared at the January meeting.

There will be a Pre-pool process for folks affected by any school closure/combined. This will use a seniority process, much like our current pool 2 process. It will not be an "interview and select" process but rather seniority-based. The goal is to get most licensed staff who are being displaced by a school closure placed. Both Peter Eckhoff and Shanon Morris will be working with Human Resources to assure contractual compliance in staffing. This needs to be completed before Spring Break. Pool 1 post 1, Pool 1 post 2, and Pool 2 will all be conducted after Spring Break. We will be presented with a staffing timeline at the January Executive Council Meeting with specific dates.

Administration will be assigned/placed into their buildings for the 2026-2027 school year prior to the pre-pool process beginning.

- \*\* The list of any teachers being laid off at the end of this school year will be determined by Spring break.
- \*\* There has been no decision made about a possible retirement incentive for this year.

FYI: January 15, 2025, is the deadline to remove licenses not currently being used for staffing purposes. This is the same date if you wish to add a license. Ahn Tran in HR will be the contact person for any changes. We anticipate the forms, along with the seniority list, will be sent to all teachers by Human Resources in early January.

Discussion on the RFT endorsement for Cedrick Frazier for Hennepin County Attorney - this position oversees and operates the Hennepin County Attorney's department.

Cedric asks the RFT to support him with an endorsement. A Labor Endorsement. He sent a message to the RFT, which was read, explaining who he is, what he has done for the community, what he believes, and what he will bring along as the Hennepin County Attorney. Cedric is a person who is present and is a great supporter of District 281. He is embedded within the community; He attends many District-wide events, including the Bird Bash, a silent auction, and dinner to raise money to support teaching and learning in the classrooms of District 281. All proceeds return to Educators! He is currently in the Minnesota House representing the North side of 43b in our school district. Cedrick has been an attorney for Education Minnesota for the last 10 years as well. After a discussion, a proposal was brought to the executive council to give a local RFT endorsement. This was seconded. The executive council was asked if there were any Questions or additional discussion. After the discussion, those present voted without objection to endorse.

Officers Elections: In February, official announcement for this year's RFT officer positions up for election for 2-year terms will be made. In April, we will vote for President, 1st Vice President, and Secondary Vice President positions for the RFT two-year terms.
