

Privacy Policy

River Turner (“Us”, “We”, “Our”) operates Hidden Spy Camera Detector ◦. This page informs You of Our policies regarding the collection, use, and disclosure of personal data when You use Hidden Spy Camera Detector ◦ and the choices You have associated with that data. We use Your data to provide and improve Hidden Spy Camera Detector ◦. You means the individual accessing or using Hidden Spy Camera Detector ◦, or the company, or other legal entity on behalf of which such individual is accessing or using Hidden Spy Camera Detector ◦, as applicable. By using Hidden Spy Camera Detector ◦, You agree to the collection and use of information in accordance with this policy.

Collecting and Using Your Personal Data

Types of Data Collected

Personal Data

While using Hidden Spy Camera Detector ◦, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

- Email address
- Usage Data
- Photo and video data
- Approximate location data

Usage Data is collected automatically when using Hidden Spy Camera Detector ◦.

Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, unique device identifiers and other diagnostic data.

When You access Hidden Spy Camera Detector ◦ by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile Internet browser You use, unique device identifiers and other diagnostic data.

We may also collect information that Your browser sends whenever You access Hidden Spy Camera Detector ◦ by or through a mobile device.

Information Collected while Using Hidden Spy Camera Detector ◦

While using Hidden Spy Camera Detector ◦, in order to provide features of Hidden Spy Camera Detector ◦, We may collect, with Your prior permission:

- Information regarding your location

- *Pictures and other information from your Device's camera and photo library*

We use this information to provide features of Hidden Spy Camera Detector ◦, to improve and customize Hidden Spy Camera Detector ◦. The information may be uploaded to River Turner's servers and/or Hidden Spy Camera Detector ◦ Provider's server or it may be simply stored on Your device.

You can enable or disable access to this information at any time, through Your Device settings.

Use of Your Personal Data

River Turner may use Personal Data for the following purposes:

- *To provide and maintain Hidden Spy Camera Detector ◦, including to monitor the usage of Hidden Spy Camera Detector ◦.*
- *To manage Your Account: to manage Your registration as a user of Hidden Spy Camera Detector ◦. The Personal Data You provide can give You access to different functionalities of Hidden Spy Camera Detector ◦ that are available to You as a registered user.*
- *For the performance of a contract: the development, compliance and undertaking of the purchase contract for the products, items or services You have purchased or of any other contract with Us through Hidden Spy Camera Detector ◦.*
- *To contact You: To contact You by email, telephone calls, SMS, or other equivalent forms of electronic communication, such as a mobile application's push notifications regarding updates or informative communications related to the functionalities, products or contracted services, including the security updates, when necessary or reasonable for their implementation.*
- *To provide You with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless You have opted not to receive such information.*
- *To manage Your requests: To attend and manage Your requests to Us.*
- *For business transfers: We may use Your information to evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Data held by Us about Hidden Spy Camera Detector ◦ users is among the assets transferred.*
- *For other purposes: We may use Your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve Hidden Spy Camera Detector ◦, products, services, marketing and your experience.*

We may share Your personal information in the following situations:

- *With Service Providers: We may share Your personal information with Service Providers to monitor and analyze the use of Hidden Spy Camera Detector ◦, to contact You.*

- *For business transfers: We may share or transfer Your personal information in connection with, or during negotiations of, any merger, sale of River Turner assets, financing, or acquisition of all or a portion of Our business to another company.*
- *With Affiliates: We may share Your information with Our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include Our parent company and any other subsidiaries, joint venture partners or other companies that We control or that are under common control with Us.*
- *With business partners: We may share Your information with Our business partners to offer You certain products, services or promotions.*
- *With other users: when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.*
- *With Your consent: We may disclose Your personal information for any other purpose with Your consent.*

Retention of Your Personal Data

River Turner will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

River Turner will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Hidden Spy Camera Detector ^o, or We are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at River Turner's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer.

River Turner will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of Your data and other personal information.

Delete Your Personal Data

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.

Hidden Spy Camera Detector ◦ may give You the ability to delete certain information about You from within the Hidden Spy Camera Detector ◦.

You may update, amend, or delete Your information at any time by signing in to Your Account, if you have one, and visiting the account settings section that allows you to manage Your personal information. You may also contact Us to request access to, correct, or delete any personal information that You have provided to Us.

Please note, however, that We may need to retain certain information when we have a legal obligation or lawful basis to do so.

Disclosure of Your Personal Data

Business Transactions

If River Turner is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.

Law enforcement

Under certain circumstances, River Turner may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

Other legal requirements

River Turner may disclose Your Personal Data in the good faith belief that such action is necessary to:

- *Comply with a legal obligation*
- *Protect and defend the rights or property of River Turner*
- *Prevent or investigate possible wrongdoing in connection with Hidden Spy Camera Detector ◦*
- *Protect the personal safety of Users of Hidden Spy Camera Detector ◦ or the public*
- *Protect against legal liability*

Security of Your Personal Data
