His approach is definitely the antithesis of the hustle culture(賣命奮鬥文化), which is based on societal metrics of success. Paul cares more about having breathing room in life so you can stay true to yourself so you don't get swept away by these powerful external forces. I'll attach the link to his interview. You can take a listen if you like. I really enjoyed it. I think I'm pretty burnt out at the moment and I need a break from all the hustling.

Some of it is financial, others can be more abstract, like the fear of failure. And these fears if we don't face them properly, they end up short circuiting the whole process and we can't figure out who we are or what gives our life meaning.

This is so telling for me and it's such a common theme for a lot of people I know; parents not letting their kids do what they truly desire and setting them on a secure default path only to have the kids quit the prestigious profession to pursue their passion as a Youtube content creator or writer.

It's officially **tax season** in the United States.

The deadline for filing is not until April 18th, but the IRS is now accepting tax returns. Millions of Americans are now beginning the process of getting their taxes done. For many, the process is both complicated and dreaded. Even if they receive a refund at the end of the process, not many people enjoy doing their taxes.

The IRS, which is short for the Internal Revenue Service, is the name of the agency responsible for collecting federal taxes in the United States. The IRS is a part of the Department of the Treasury.

The IRS began in 1862, although it wasn't called the IRS back then. It was a federal office intended to collect income tax from US citizens in order to fund the fight against Confederacy during the Civil War. At the time, the income tax was meant to be a temporary solution, and after an initial period of ten years, the office was dissolved in 1872.

Americans paid no federal income taxes again until 1913, at which time the Sixteenth Amendment of the United States Constitution was **ratified**. The Amendment authorized Congress to impose an income tax -- which they did later that year. The Revenue Act of 1913 brought the federal income tax back . . and it's been here ever since. The Act created the Bureau of Internal Revenue to collect the new taxes. In 1953 the Bureau was renamed to what it is known as today: the Internal Revenue Service. IRS.

These days, the IRS collects tax on pretty much every form of income you can think of.

There's **regular income**, the kind you might earn if you work a standard job where you receive a paycheck from your employer. This sort of tax is the easiest to calculate. Usually, a certain amount of tax is withheld from each of your paychecks. When you file your taxes, you and the IRS are essentially comparing numbers. Depending on any other sources of income you have, you

might still owe more taxes. Or, if you earn less than a certain amount during the year, you may have paid too much tax. If this is the case, congratulations. You'll be one of the people receiving a **tax refund** from the IRS.

There are all sorts of other income which must be reported. Dividends from any stock you own. Gains from any stock or cryptocurrency that you sold during the year, which are known as **capital gains**. If you're self-employed or own a business, you'll owe taxes on that income. Income from properties you own, from lottery or gambling winnings . . . even money from items you sold to clean out your garage on Ebay.

It all gets reported and calculated.

Depending on the final amount of taxable income you have and the sources of that income, the tax you owe will be calculated at different percentage rates.

This all used to be very complicated for an individual to figure out. Most people would pay a tax professional to handle their taxes for them, rather than go through all the difficult forms and paperwork themselves.

But these days, there are many online sites and tax software available that will walk you through the process and file all of the paperwork digitally. These sites and programs will often cost money, but rarely will it be close to what a tax professional would cost you.

And it might not cost anything.

In fact, many Americans who earn less than \$73000 per year are entitled to file their taxes for free. But very few people know about or take advantage of this program, which is offered directly from the IRS. They estimate that only about 5% of all eligible taxpayers take advantage of the free filing program. In previous years, even big name online websites like Turbotax, that might otherwise cost a few hundred dollars, were required to offer a free version of their filing service through the IRS website. Unfortunately, this requirement is no longer in place, although the IRS will still provide links to other services that still do offer a free filing option.

Even with so much of the process now done online and digitally, the IRS is constantly behind schedule and facing a huge backlog of tax returns to be sorted through.

In 2022 President Biden signed into law the Inflation Reduction Act. One of the provisions of that new law was to increase funding to the IRS by 80 billion dollars over the next ten years. This money is intended to aid in the hiring of tens of thousands of new IRS agents and to update the IRS's investigative technology. The goal is to ensure more people are paying their fair share of taxes.

A handful of Republicans in Congress have been trying to push a replacement tax system for the last two decades. This system would eliminate the income tax altogether and replace it instead with a national sales tax. Under the proposed system, a 23% tax would be added to the purchase price of all goods and services.

However, this proposed "Fair Tax" as it is called isn't very popular and has little chance of actually becoming law.

The IRS and the federal income tax are unlikely to be going anywhere soon.

So I better go get started on mine!
