Minutes of meeting on 19th March 2018

Minutes were agreed and all matters arising dealt with below

Social:

CH ran a very successful event, the family tournament, raising £300 so thanks go to her

Fun Run is 17/6 so we need volunteers to help. Action: CJ to get food details from SH

Open evening is the 28/6 during the Lisvane festival

Velothon is 8/7

BBQ 13/7 SH to organise- may incorporate a "drinking" tournament or do this separately

PJ, with SJ to organise Ball at Llanishen Golf Club 13/10

Facebook Account – ERJ confirmed that Victoria Morgan is happy to manage the club's Facebook page but needs administrator access from LC in order to update the page. Paula to check with LC if he wishes to keep the page or we start with a new one **Action PJ**

Finance:

SF reported that the Funding account contained a total of £3,937

Team Captains Report:

SS reported that the Ladies 2nds won their first match, ladies 1st lost theirs

Men's 1st lost their match.

CH agreed they would like to enter a second ladies team into the winter league Action CJ

SS raised the issue that we may need to check the rules around how many tournaments people can enter. This will really only be an issue for juniors/men - **ACTION MJ to check the rules**

House & Grounds:

New cooker needed for club house. The view of SF is that we buy this ourselves to show CAC we are prepared to pay for our own items. Get price for new one

MG has washed court 1 &3, wishes the go ahead to do court 2 which was agreed

SH commented that chairs and the rollers are being left out. The roller needs to be kept in water. Also the radiators are being left on whilst the building is empty so they need to be turned off.. SH has cleaned the gutters and removed the old nets. SF and JA put the new nets up.

Court 1 floodlight has been done. The manual shutter has been fixed and CB fixed the gate as it got stuck due to the higher level of tarmac.

New trees are doing well and 80% have taken. Julian will be coming to inspect the trees over the next 3 years

Membership:

The levy was discussed and it was agreed to raise it by £10 for every member apart from yr 6 and below. We will still be the cheapest club around. New figures will be:

Coaching:

The coaching times for the school year commencing Sept 2018 needs to be agreed by end June, so TSH to submit his request. TSH was asked if he can coach on Thursdays in Sept, he will let us know-**Action TSH.** TSH pointed out he has agreed to finish coaching earlier on Monday evening due to the ladies matches. SS said we have to play matches on Monday as the men had Friday and Saturday.

With the court shortage in regard to Tuesday nights TSH agreed to finish at 7 on courts 2&3, leaving court 1 free from 6.00

TSH is running a Tournament 28/5 to 2/6 and 9/5. As a compromise to social mornings on Tues/Wed TSH will aim to run this tournament from 1030 t 6.15

TSH to send CB details so he can book the courts out **ACTION TSH**

Tony raised £122 from the last tournament (61 entrants).

SH asked TSH to ensure all balls and drinks bottles are cleared from the courts at the end of his coaching session. TSH agreed and said he does ask the kids to do this currently.

Contract

The sub committee have put together a contract using the LTA template as a basis and sent it to TSH to review. TSH said he cannot look at it until the end of June. TSH said the contract was virtually

agreed with Leigh last year and now we are asking him to change it again. Mark Lewis from Tennis Wales is happy to come to meet Tony to get this sorted so we need Tony's comments by this visit (date tbc) with a view to having the contract in place by the end of June 18.CH felt it was unreasonable to pressurise Tony but it was explained this has been an issue for well over a year and there have been many attempts to resolve it. It is in everyone's interest to have a contract in place.

Courts

Painting on the new courts will take place end May dependant on the weather. Feedback was received from Allt yr yn who said our courts were not good enough to play on. TN asked when would it be appropriate to approach CAC re funding for resurfacing, SF and JA said they would rather wait until next year, however if it becomes a safety risk then they would ask them earlier.

Discussion around what surface we should put down, ideally we need to ask members for their views. Cost from Rhiwbina club was 50-73K for resurfacing 3 courts in artificial clay. PJ will ask Mark Lewis to visit the club to assess the state of courts 1-3. Another suggestion was we tarmac court 1 and do 2 & 3 with clay.

DW suggested we copy the wording that CAC use when contacting our members. This would need to cover asking parents for consent to photos and email contact. JA to chase Abbie at CAC.. Tennis Rungs is a separate issue as not run by us.
