Information We Collect

We do not collect any sensitive personal data. The Games may collect the following non-sensitive data:

- **Device information:** Device model, operating system, and unique device identifiers.
- **Usage data:** In-game interactions, session duration, and crash reports.
- **Analytics data:** Data used for understanding player behavior and improving the Games.

This data is collected using third-party SDKs to enhance the performance, analytics, and functionality of the Games.

Third-Party SDKs

We use the following third-party SDKs in our Games:

1. Adjust SDK

Adjust helps us analyze user acquisition and optimize game performance. Adjust collects anonymized device and event data for attribution purposes.

2. Facebook Unity SDK

Facebook Unity SDK enables certain social features and measures app installs. Facebook collects aggregated and anonymous usage data.

3. Unity Analytics

Unity Analytics collects anonymized data to help us understand player behavior and improve game experiences. Unity may collect data such as session duration, device type, and in-game activity. We do not share your data with any third parties except as necessary for the operation of the Games and the services provided by Adjust, Facebook, and Unity.

We implement industry-standard security measures to protect your data. However, please note that no method of transmission over the Internet is 100% secure.

Children's Privacy

Our Games are not intended for children under the age of 13. We do not knowingly collect personal data from children under 13. If you believe we have collected such information, please contact us at [your contact email] so we can take appropriate steps to delete it.
