

TERMS & CONDITIONS

UNLOCK TAOKAENOI'S FORTUNE

1. Campaign UNLOCK TAOKAENOI'S FORTUNE ["Campaign"] is organized by Taokaenoi Food & Marketing PCL ["Organizer"] and is opened to permanent residents of Malaysia or Malaysian nationals with a valid MyKad 25th September 2023 ["Participants"].
2. Individuals from the following groups are not eligible to participate in this Campaign:
 - Organizing Staff [Including affiliated and related companies] and their immediate family members [children, parents, siblings, including spouse]; and/or;
