3. Participation Requirements

- Create **original content** on X (Twitter) about FightID x Holoworld AI:
 - Vision & mission
 - o Al-driven features & identity integration
 - ICO highlights
- Display name must include P emoji
- Tag: @JoinFightID and @HoloworldAI
- Acceptable content formats: Tweet, Thread, Video, or Article
- Submission deadline: Nov 1, 2PM UTC

4. Submission Process

- 1. Log in at launch.holoworld.com/ico/fight
- 2. Connect your X account
- 3. Submit up to 5 content links
- 4. Updates allowed until the deadline

Reward Structure

Guaranteed Minimum Allocation:

All qualified participants will receive a **minimum of \$100 USD allocation**.

Details:

 The exact allocation for each participant will be determined by the FightID x Holoworld AI team and announced at a later stage.

- Allocation depends on content quality, engagement, and overall participation.
- Total allocation pool comes from 0.25% of the presale allocation.
- No oversubscription required all qualified participants receive a fixed allocation.

- Each creator may only receive **one allocation tier** (highest tier)
- Linked and verified X account is mandatory
- Hololaunch and FightID teams hold final interpretation rights

- Creator allocation confirmation window: Nov 1 Nov 3
- Outstanding content may be **reused by official channels** for promotion
- Violations result in immediate removal from rewards
