# **Instructions for authors**

# Title of the article (Times New Roman, font size 14, bold)

- 1. Papers must be in English
- 2. Text Microsoft Word: the page is A4 (book orientation); font Times New Roman, size 12, 1.5 interval. The manuscript of the paper should be 10 to 20 pages.
- 3. Edges: 2 cm from all sides
- 4. Paragraph 1.5 mm
- 5. Section headings should be identified by Arabic numbers followed by a dot. All main words should be capitalized. Subheadings should be identified by Arabic numbers followed by a dot, e.g. 2.1, 2.2, etc., and written in capital letters and italicized.
- 6. Tables, graphs, and diagrams should be named, numbered (in Arabic numerals, in the order of the first mention: Figure 1, Table. 1, etc.), and presented in the text of the article.

<u>Description of figures / graphs / diagrams</u> – under the figure, graph, diagram, alignment to the centre:

Fig. 1. Title

Captions for tables are placed above the table.

<u>Please submit figures in electronic form</u>, as JPG or TIFF files (in a separate file with the name and number, as in the text (eg. Fig1.tif, Fig2.tif).

- 7. The formulas should be performed using the formula editor.
- 8. Displayed formulas should be numbered consecutively throughout the manuscript as (1), (2), etc. against the right-hand margin of the page. When referring to an equation with its number in text please use "Equation (1)", with a capital "E".

- 9. <u>References</u> (in square brackets) served at the end. The sources of literature should give the names of all authors cited articles without cutting their list, the full title of the article, commonly accepted abbreviated name of the journal, volume, number, and pages. Titles of books (monographs, collected works), theses, abstracts, and patents, etc. should be given in full.
- 10. The list of references should be typed entirely in Latin, translated. If the article has a DOI, it must be submitted at the end.
