

When Pippen was selected for his first NBA All-Star game during the 1990–91 season, he had already established himself as a reliable scorer and defenseman.

The Bulls appreciated uncommon accomplishment under Pippen's authority, remembering their initial three-peat for the mid 1990s and second title run in the last part of the 1990s.
