**2025 AABA Law Foundation and the Salle Yoo and Jeff Gray Charitable Fund
Summer Grants**

The Asian American Bar Association of the Greater Bay Area (“AABA”) Law Foundation is offering two grants to help fund qualified summer law clerks to work on legal projects that provide free or low cost legal services to the Asian American community or other under-represented communities. Applicants must have a summer position with a non-profit/government legal organization or judicial officer/organization that has agreed to supervise the applicant for the summer of 2025. The grant will be funded by the **AABA Law Foundation and the Salle Yoo and Jeff Gray Charitable Fund**.

An increasing number of Californians and Americans lack access to representation. The Yoo-Gray family is honored to award these summer grants to support budding lawyers who have chosen to dedicate themselves to increasing access to justice for Californians, especially in our Asian American communities.

Eligibility

All current law students are eligible to apply, but preference is given to first and second-year law students at a San Francisco Bay Area school (Stanford University, UC Berkeley, UC Davis, UC Law SF, University of San Francisco, Golden Gate University, Santa Clara University, or McGeorge School of Law).

Applicant Requirements (Instructions and application attached)

- Summer legal employment in a government position, non-profit organization, or in a judicial externship:
 - **Public Interest Grant - Requirements.** Interested applicants should meet the following three requirements:
 - Have a summer position with a non-profit legal service organization or public/government agency located in the Bay Area;
 - Will work on a project(s) that provides legal assistance to the Asian American community or other under-represented communities;
 - Commit to 8 -10 weeks of work on the project(s) this summer, if practicable.
 - **Judicial Externship Grant - Requirements.** Interested applicants should meet the following two requirements:
 - Have a summer judicial internship or judicial externship in Northern California;
 - Commit to 8-10 weeks of work this summer, if practicable.
- Preference for Bay Area law school attendance or an intent to practice law in the Bay Area after graduation
- Preference for 1L or 2L law student
- Financial need

- A strong academic record and/or other indicators of future career success
- Membership in AABA will be considered and in-person acceptance at the AABA Summer Diversity Reception (date to be determined, but likely will be in late June) is expected/encouraged.
- Submission of personal statement and essay. (Refer to instructions attached)

The deadline to submit applications is **April 28, 2025**. Please email your application in one PDF file to aaba.bayarea@gmail.com with “2025 Yoo/Gray Summer Grants - [your name]” in the subject line. Do not send multiple PDF files.

Selection

After receipt of applications, the selection committee will convene and interview the top candidates on **June 7, 2025** (the interviews to be held between 9am and noon by video conference). AABA will award the summer grant at AABA’s Annual Summer Diversity Reception, which will be at UC Law SF in San Francisco on **June 26, 2025**.

Selection criteria include past, present and future community service or public interest work for the Asian Pacific American (APA) community or other underrepresented communities; demonstrated leadership in the APA community; demonstrated financial need; and past, present and future commitment to the Bay Area.

The AABA Law Foundation also strongly encourages all grant recipients to:

- Become a Law Student Member of AABA; and
- Become a Lawyer Member of AABA upon graduation from law school.

INSTRUCTIONS:

AABA Summer Grant Application Submissions

1. Complete the application form (attached)

2. Submit a personal statement, no more than 3 pages, double-spaced, that includes the following:

- (a) A description of the type of work that you will pursue under the grant;
- (b) A description of your qualifications;
- (c) The name of the non-profit legal service organization or the judicial externship that you will be working with, including a reference contact and telephone number;
- (d) A description of any other grants, compensation, or financial aid you will receive for this summer's work;
- (e) Additional information beyond what is reflected in your resume regarding your past, present and future community service or public interest work for the Asian Pacific American (APA) community or other underrepresented communities; demonstrated leadership in the APA community; demonstrated financial need; and past, present and future commitment to the Bay Area;

2. Submit an essay of no more than 3 pages, double-spaced, discussing:

- (a) Why you have chosen to work this summer at the non-profit legal service organization/government organization or the judicial externship and how you believe the summer work will enhance your career objectives; and/or
- (b) What has been your experience in overcoming economic or other discriminatory barriers, and what role do you see yourself playing in advocating for others faced with economic or other discriminatory barriers?

3. Law school statement:

If you are not currently a law student at a San Francisco Bay Area law school (Stanford University, UC Berkeley, UC Davis, UC Law SF, University of San Francisco, Golden Gate University, Santa Clara University, or McGeorge School of Law), please explain in a separate statement (no more than one page), your commitment to serving the Asian Pacific American community in the Bay Area.

4. Submit a resume with the application.
