

Computing Curriculum: Thematic Approach

The Computing curriculum is designed to develop digital literacy, computational thinking, and technological creativity. Through interconnected themes, students gain the knowledge and skills to navigate, innovate, and engage safely in an increasingly digital world. These themes ensure a comprehensive and progressive approach to computing education.

1. Computational Thinking and Coding Students develop problem-solving skills through the principles of computational thinking, including decomposition, abstraction, pattern recognition, and debugging. Starting with simple algorithms and programs (Year 1), students progress to creating complex, efficient programs using variables, repetition, and conditions (Year 6). This theme builds logical reasoning and creativity.

2. Digital Literacy and Online Safety This theme equips students with the skills and understanding to use technology responsibly and safely. Topics include managing online identities, recognizing and reporting online bullying, and understanding privacy settings. Students learn to critically evaluate online content, ensuring safe and ethical digital engagement.

3. Information Technology and Media Creation Students learn to use digital tools to create and present information effectively. This includes word processing, data handling, and multimedia creation such as video editing, animation, and augmented reality. From designing simple presentations (Year 1) to building websites and app prototypes (Year 6), students master the tools of modern communication.

4. Data Handling and Analysis This theme develops students' ability to collect, organize, and interpret data. Activities range from creating simple pictograms and bar charts (Year 1-2) to using spreadsheets with formulas and statistical functions (Year 5-6). Students learn to analyze data critically and apply it to real-world problems.

5. Creativity and Digital Expression Students explore their creativity using digital tools to design animations, music, and visual art. Starting with simple photo editing and sound recording (Year 1-2), they progress to creating 3D models, digital art, and multimedia projects that express ideas and stories in innovative ways.

6. Communication and Collaboration This theme focuses on using technology to collaborate and communicate effectively. Students engage with tools like blogs, shared drives, and online forums to work together on projects. They learn to tailor their communication for different audiences and purposes, fostering teamwork and global engagement.

7. Understanding Computer Systems and Networks Students gain insight into how digital systems and networks function. From learning about basic computer hardware and networks (Year 3) to exploring internet infrastructure and web page design using HTML (Year 6), this theme develops their understanding of the interconnected digital landscape.

Through these themes, the Computing curriculum ensures that students not only develop technical proficiency but also understand the ethical, social, and practical implications of technology. They are prepared to innovate, collaborate, and thrive in a digital world while engaging responsibly and creatively with the tools of the future.

4	<ul style="list-style-type: none"> - I can analyse information to make a judgement about probable accuracy and I understand why it is important to make my own decisions regarding content and that my decisions are respected by others. - I can describe how to search for information within a wide group of technologies and make a judgement about the probable accuracy (e.g. social media, image sites, video sites). - I can describe some of the methods used to encourage people to buy things online (e.g. advertising offers; in-app purchases, pop-ups) and can recognise some of these when they appear online. - I can explain why lots of people sharing the same opinions or beliefs online do not make those opinions or beliefs true. - I can explain that technology can be designed to act like or impersonate living things (e.g. bots) and describe what the benefits and the risks might be. - I can explain what is meant by fake news e.g. why some people will create stories or alter photographs and put them online to pretend something is true when it isn't.

I can explain why someone would need to think carefully

3	<ul style="list-style-type: none"> - I can explain why spending too much time using technology can sometimes have a negative impact on anyone, e.g. mood, sleep, body, relationships; I can give some examples of both positive and negative activities where it is easy to spend a lot of time engaged (e.g. doing homework, games, films, videos). - I can explain why some online activities have age restrictions, why it is important to follow them and know who I can talk to if others pressure me to watch or do something online that makes me feel uncomfortable (e.g. age restricted gaming or web sites).

2	<ul style="list-style-type: none"> - I can explain how passwords can be used to protect information, accounts and devices. - I can explain and give examples of what is meant by 'private' and 'keeping things private' - I can describe and explain some rules for keeping personal information private (e.g. creating and protecting passwords). - I can explain how some people may have devices in their homes connected to the internet and give examples (e.g. lights, fridges, toys, televisions).
3	<ul style="list-style-type: none"> - I can describe simple strategies for creating and keeping passwords private. - I can give reasons why someone should only share information with people they choose to and can trust. - I can explain that if they are not sure or feel pressured then they should tell a trusted adult. - I can describe how connected devices can collect and share anyone's information with others.
4	<ul style="list-style-type: none"> - I can describe strategies for keeping personal information private, depending on context. - I can explain that internet use is never fully private and is monitored, e.g. adult supervision. - I can describe how some online services may seek consent to store information about me; I know how to respond appropriately and who I can ask if I am not sure. - I know what the digital age of consent is and the impact this has on online services asking for consent.
