Under our positions, League believes:

- LWV believes all persons should receive fair treatment under the law.
- LWV believes that provision of food, housing and emergency healthcare are basic human needs, that our federal government has primary responsibility for ensuring those needs are met, and that other government entities should take secondary financial responsibility.
