

Academy Swim Club (ASCO and Academy Masters Swim Team (AMST) Travel Policy*

8/13/21

ASC and AMST Members who are fully vaccinated between 14 days to 12 months of travel** may return to campus immediately after travel, so long as they:

- a. Travel at least 14 days after their final vaccination;
- b. Participate in the [Safe Travels Hawai'i](#) program (if traveling outside the State of Hawai'i);
- c. Have no symptoms of illness consistent with COVID-19.

**HPA reserves the right to ask for a copy of your vaccination card. Without proof of vaccination, you may be subject to mandatory quarantine.

OR

ASC and AMST members who are unvaccinated or not fully vaccinated have two options for return to campus:

1. Testing pathway:
 - a. Participate in the [Safe Travels Hawai'i](#) program (if traveling outside the State of Hawai'i);
 - b. Quarantine away from campus for five days upon arrival to Hawai'i Island. Please keep in mind, the day you arrive is day zero (0), not day one (1);
 - c. Provide proof of a negative COVID-19 Nucleic Acid Amplification Test (NAAT) on or after day five by emailing test results to the program.
 - d. Have no symptoms of illness consistent with COVID-19.

-OR-

1. If an ASC or AMST members prefers not to receive a COVID-19 Nucleic Acid Amplification Test (NAAT) at any point following a household member's travel they must:
 - a. Participate in the [Safe Travels Hawai'i](#) program (if traveling outside the State of Hawai'i);
 - b. Quarantine away from campus for 10 days upon arrival to Hawai'i Island. Please keep in mind, the day you arrive is day zero (0), not day one (1);
 - c. Have no symptoms of illness consistent with COVID-19.

Fully Vaccinated Individuals

Fully vaccinated individuals who are deemed a close contact of someone who has tested positive for COVID-19 will be required to **quarantine for five days while monitoring for symptoms then need to take a NAAT/PCR COVID-19 test on or after the fifth day of exposure**. So long as they do not have ongoing exposure to the COVID-19 positive case, fully vaccinated individuals may return to campus with proof of a negative test result, clearance from a U.S. healthcare provider, and approval from our Health Services Department. A person qualifies as fully vaccinated two weeks after their second dose in a two-dose vaccine series of Pfizer-BioNTech or Moderna; or two

weeks after a single-dose vaccine of Johnson & Johnson's Janssen. If you do not meet these requirements, regardless of your age, you are not considered fully vaccinated.

Unvaccinated or Not Fully Vaccinated Individuals

Unvaccinated or not fully vaccinated individuals who are deemed a close contact of someone who has tested positive for COVID-19 will need to **quarantine for 14 days** while they monitor for symptoms. Unvaccinated or not fully vaccinated individuals may return to campus with clearance from a U.S. healthcare provider and approval from our Health Services Department.

Given the current rate of infection on Hawai'i Island, we are asking that everyone routinely monitor themselves for symptoms — which could be mild, so please pay close attention. If you develop symptoms, please contact your healthcare provider and HPA Health Services at infirmary@hpa.edu.

We appreciate all that our faculty and staff are doing to maintain the health and safety of our entire community — especially through vaccination, which has proven to be our most effective tool in the fight against COVID-19.
