APPLICATION FOR ADOPTION

Adoption Process and Fee Agreement:

1. The adoption fee, in accordance with the current Tails to Tell Animal Rescue Shelter Ltd. (TTARS) must be paid in full before the applicant/adoptioner can remove the animal from the shelter or adoption event.
2. The adoption fee may include an additional refundable deposit of \$50.00 if the animal is not spayed or neutered at the time of the adoption. This deposit will be returned with proof of spay or neuter, along with deposit receipt, if presented within 30 days of the adoption or, in the case of an animal who has not reached sexual maturity, within 30 days after the animal has reached six months of age.
3. **All animal adoptions will undergo a one week (seven day) trial starting from the date the animal leaves the shelter or event location. During that time, TTARS will remain the primary owner and can require the animal be returned at any time for any reason.**
4. The applicant can return the animal during the one week trial at any time and will be refunded the full adoption fee and the spay or neuter deposit (if applicable). A TTARS receipt will assist in the processing of the refund. If the seven day trial has elapsed, the animal will be considered to be adopted to the applicant. The applicant then owns the animal outright and will be responsible for the animal as per the Owner Responsibility section of this agreement.
5. Full or partial refunds will not be given if the animal is returned after the seven day trial.
6. If medical documentation is not provided at the time of adoption, it will be mailed to the owner's address on the application. If these documents are not received, please contact the shelter, after two weeks.

Owner Responsibility:

1. To provide proper access to food, water, shelter and humane treatment at all times.
2. To provide veterinary exams and immunizations as needed and care should the animal become ill or injured.
3. To not allow the animal to breed and have the animal spayed or neutered by a licenced veterinarian within 30 days of adoption or within 30 days of the animal reaching six months of age.
4. To licence the animal in compliance with the laws and ordinances of the municipality in which the animal resides.
5. To notify Tails to Tell Animal Rescue Shelter if the owner decides at any time they can no longer keep the animal.
6. To not allow the animal to be used for medical or other experimental purposes.

Affirmation of Agreement:

1. Tails to Tell makes every effort to insure the animal's health is good and the animal is a good match with the new owner. I understand that TTARS has made no representations, express or implied, as to the health, temperament, or training of the animal(s) given to me and hereby release TTARS and its representative from all liability once I am the sole owner and the animal is in my possession.
2. I understand and agree that representative of TTARS reserves the right to inspect my home or call my home, to assure the animal is being treated properly and cared for during the 7 day trial period.
3. I have read this application in full and it was explained to me. I understand and accept the rights and obligations involved.
4. I understand that I will be required to pay an adoption fee and possibly a spay and neuter deposit in accordance with the TTARS schedule.
5. I agree that all information provided is correct and truthful to the best of my knowledge.
