- School is excited about the Children's Show
- Class Size Reduction – 2 Year Process – Must be done by 2027
 - Superintendent visit to discuss the process to reduce class sizes
 - New staff has been interviewed – 9 new staff
 - K-2 focused
 - 20 children per class
 - 3-5
 - No new admissions
 - 22 children per class
 - New Classrooms
 - Science Room/Planetarium will be turned into a classroom
 - Teachers Lounge will be made into a classroom
 - Lounge will be the room off of the gymnasium
 - KB14 classroom would be split into two classes
- Galinda – leaving shortly for leave
- Will start to look at all of the children at the school to ensure they are actually living in the district
