After my mother's displacement from her senior home in 2016, I ran for Berkeley City Council, championing impactful legislation that has resulted in the creation of over 1,000 affordable homes, expanded paid family leave, and established a comprehensive wildfire prevention plan. My dedication to community safety led to the implementation of civilian response teams for mental health crises, allowing law enforcement to focus on more serious crimes. Additionally, my leadership secured a \$1,000,000 grant for public safety in the City of Berkeley.**

**As a lifelong Democrat and the nephew of former Congressman Ron Dellums, I actively participate in various Democratic clubs in the East Bay, including the Alameda County Democratic Central Committee, the John George Democratic Club, the El Cerrito Democratic Club, and the Berkeley Democratic Caucus. Drawing inspiration from my work as a field director on the Obama Campaign in Minneapolis, I pursued a career as an Environmental Attorney after attending law school at UC San Francisco College of Law (formerly UC Hastings). My goal is to contribute to the rebuilding of Alameda County, creating a safe, inclusive, and equitable community for all.**

1. Please describe your relationship, if any, with the Jewish community in the area you serve as an elected official:

**Having served as a Berkeley Councilmember for over seven years, I have consistently demonstrated my dedication as a trusted leader whom constituents can rely on for guidance. Throughout my tenure, my office has maintained an open-door policy, ensuring I make time to meet with community members and address their concerns within our district. Notably, leaders from the Jewish community have scheduled meetings with my office to discuss safety concerns for their members. In these sessions, I have actively listened and offered my support. My role has allowed me to**

**be an ally for the Jewish community, and I am committed to sustaining and strengthening these relationships as I extend my open-door policy to the County level.**

2. Hate Crimes: Do you see Anti-Semitism as a Hate Crime? How do you propose working on Hate Crimes if you are elected?

**Certainly, Anti-Semitism qualifies as a Hate Crime. In Berkeley, I played a key role in co-sponsoring the resolution that officially recognized racism as a public health crisis due to its immediate threat to our community's safety. This initiative empowers us to organize a series of town hall sessions, engaging all community members, City workers, and small business owners in discussions addressing the concerns of people of color and marginalized communities. Our goal is to formulate strategies and programs, with a particular focus on Mental Health Programs for keeping the unhoused housed, fostering greater inclusivity, understanding, empathy, compassion, and unity.**

**These sessions aim to enhance anti-racist capacity building and commitments within the city. I firmly believe that as elected leaders, it is our responsibility to educate the public on critical issues like these. If elected as Supervisor, I will carry these principles to the County level, advocating for measures against Hate Crimes and reinforcing our collective commitment to a more inclusive and compassionate community.**

**I oppose efforts of selective prosecution; they reek of bias. I have had discussions on this, and at this time, I have made my opposition clear in every public and private forum.**

**Absolutely, I am committed to fostering an inclusive and respectful learning environment within the Ethnic Studies Program. I believe it is crucial to incorporate diverse perspectives, including Jewish-American lesson plans, into the curriculum to provide a comprehensive understanding of our nation's rich tapestry. It is my stance that no group, including the Jewish community, should be subject to denigration in educational materials. If elected, I would actively support policies that ensure the inclusion of Jewish-American lesson plans, contributing to a curriculum that promotes cultural understanding and appreciation.**

**Additionally, I am dedicated to addressing and rectifying any lesson plans that perpetuate negative stereotypes or misinformation about Jews, Judaism, or Israel. It is essential to create an educational framework that encourages**

**respect, tolerance, and accurate representation. I will work collaboratively to review and revise any materials that may perpetuate bias or harm, ensuring that our educational system reflects the values of diversity, equity, and inclusion.**

5. As a Democrat, what steps can we take to help fight anti-Semitism on both the left and the right?

**As a Democrat, addressing anti-Semitism requires a multifaceted approach that transcends political divides. Firstly, fostering education and awareness within the party is crucial.
