Abstract: Abstract is a short summary, that includes the background, overall purpose, methods, findings and conclusion in a clear and concise form. Abstract should be written in proper English. Word count for abstract should be maximum 250 words. Abstract should be written in 1 (one) paragraph. Abstract should be in font Times New Roman, size 12pt, single space and not italic. In the abstract for a research paper, it is recommended to use the numerical results. The abstract of the review article should indicate the issues under study, and as a result, present the author's summary of the analysis. The text should be concise and original. It is not appropriate to use the sentences in the Abstract from the text of the paper.

Keywords: The purpose of keywords is to provide the insight to the reader into the contents of the paper. They should reflect the area of the research. Font Times New Roman, size 12pt, number of keywords should be 3-5 keywords.

INTRODUCTION**Introduction**

Journal articles consist of Introduction, Literature Review, Research Methodology, Results and Analysis, Conclusions, and Bibliography. Journal articles are written on A4 paper (21cm x 29.7cm) and use Normal margins. Journal articles are written using Times New Roman font, size 12pt, spaced 1 and justified. Journal article submissions must be in MS Word format. The number of pages of journal articles is a minimum of 4 pages and a maximum of 8 pages. The column used is one column only.

Research purposes

The journal articles submitted will be subject to a review process in the first stage of selection which includes the article format and the Turnitin test results before proceeding to the next stage.

The plagiarism process uses the plagiarism tool, Turnitin. Turnitin yield limit on an article is 30% where for each source the maximum percentage of similarity is 4%. The title of the section is written in Times New Roman Capital, 12pt, Bold. While the title of the subsection is written in Times New Roman, 12pt, Bold. Titles of sections and subsections do not use numbers. Can be completed with a chart or schematic illustrating the implementation steps.

In this section, the results of the research are explained and at the same time a comprehensive discussion is given. Results can be presented in the form of images, graphs, tables and others that make it easy for readers to understand. The discussion can be carried out in several sub-chapters.

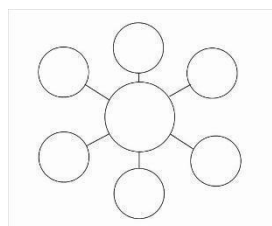

Times New Roman 12pt, with hanging format 10mm. The bibliography attached to the Bibliography must only be listed in the reference marked with the author's last name and year, as an example (Kotler, 2009). Authors are not allowed to refer to wikipedia and web pages whose credibility is not trusted. The following is an example of writing a bibliography using APA-Style:
