The introduction is written systematically starting from the general background, review of previous literature (state of the art) as the basis for the statement of scientific novelty of the article, and research problems. At the end of the introduction, the purpose of the article should be stated. The introduction must answer (1) the rational and essential reasons that make researchers interested in conducting research based on facts, data, references and previous research findings; (2) the complexity of the problem if the problem is left unaddressed and will have an impact that complicates, hinders, disrupts, and even threatens; (3) emphasise the differentiator and the novelty side and then describe what the author is aiming for.

Methodology [Typed in Bold, 13 Pt Font-Size]

This section should be written descriptively and explain the overall research methodology. Describe the approach used, how to obtain data, research location, data collection methods, and data analysis techniques. This explanation aims to provide readers with a clear picture of the research implementation process. For Review Articles, the methodology is written descriptively, including the topic analysed, the theory and/or law used in the analysis, and the limitations applied in the review.¹

In this section, researchers can discuss each aspect of the problem one by one. Results and Discussion contains the findings of the research and its scientific discussion. Write scientific findings that are supported by adequate data. In addition, it should also explain the comparison with the results of other researchers with similar topics. The research results and findings must be able to answer the research hypothesis in the introduction.²

The writing of results and discussion can be added with supporting graphs, tables, or pictures. The systematisation of the results and discussion must refer to the formulation of the research problem. Writing can be made with a subtitle format based on the problems discussed. Writing Quranic verses and hadith: as the following example (Q.s. al- Baqarah [2]: 183). Hadith writing mentions the name of the narrator (H.r. al-Bukhâri and Muslim).




IMAGE 1. Location of Research, Makam Dawa Village, Brebes Regency
