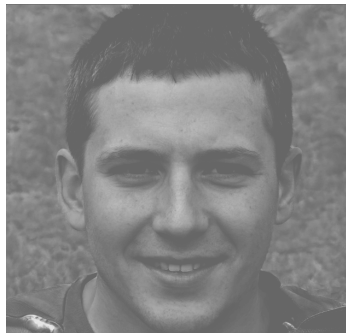

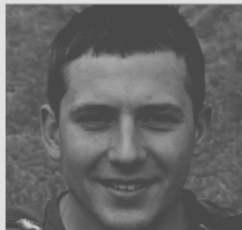

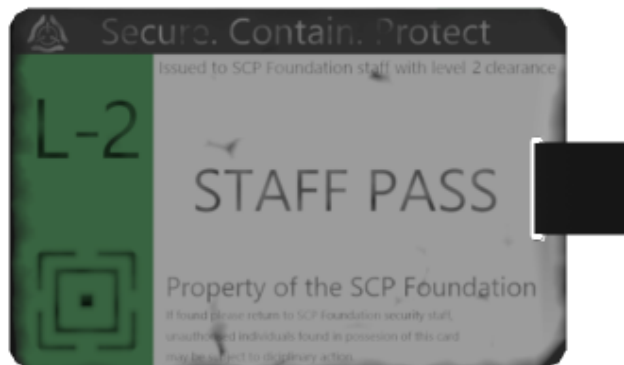
From the office of Site Director
