

@HENRYCARMOORES & Visit Saudi GIVEAWAY PHASE 2

Terms and Conditions

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. INTERNET ACCESS IS REQUIRED FOR ENTRY.

These are the official rules (the “Official Rules”) that govern the taking place from July 17, 2026 through July 18, 2026 (the “Giveaway”). Participation in the Giveaway constitutes Entrant’s (defined below) full and unconditional acceptance of these Official Rules.

1. Sponsor, Promoter, Administrator:

- a. This Giveaway is sponsored by Saudi Tourism Authority, PJ8P+58, Al Raed, Riyadh 12355, Saudi Arabia (the “Sponsor”).
- b. This Giveaway is promoted by Influencer Arabia, 3485 Prince Sultan Bin Abdulaziz, 7124 Al Olaya Dist, 1211, Riyadh, KSA (the “Promoter”).
- c. This Giveaway is administered by Influencer Ltd., Floor 2, 51-53 Great Marlborough Street, London, England, W1F 7JT and [@henrycarmoores](#) (the “Administrator”).

2. Eligibility. This competition is open to residents of the United Kingdom aged 18 or over at the time of entry, who also hold a valid UK passport, and are eligible to travel during the prize travel period, from 1 August to 15 December 2026. Plus one of the prize winners must also be aged 18 or over and have a valid UK passport. Entrants shall not include persons residing in countries outside of the UK or any jurisdiction where the Giveaway is prohibited by law, in addition, those who do not hold a British Passport shall be barred from entering the giveaway. Additional eligibility requirements may be announced during the Event (as defined below). Employees, officers and directors of the Sponsor, the Promoter, and the Administrator, and their respective subsidiaries, affiliates, sponsors, suppliers, partners, advertising and promotion agencies, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers, and directors are not eligible

to enter. To participate in the Giveaway, you must be an authorised account holder of a valid Instagram account, which is free to create. Entrants must have an Instagram account to be contacted by the Administrator if they are selected as a Potential Winner. By entering, you confirm that you and your chosen guest are legally eligible to travel internationally and enter the Kingdom of Saudi Arabia. The Promoter reserves the right to require proof of identity, age, and UK residency as well as a British Passport before awarding the prize.

3. Entry Period. The Giveaway will begin on July 17, 2026, at 15:30 PM UK time and shall end on July 18, 2026, between 15:00 PM and 19:00 PM UK time (the “Entry Period”), where one participant will be selected at random and sent an Instagram DM. The official timekeeping clock shall be the Administrator’s clock. Entrant’s entry must be received by the Administrator within the Entry Period to be entered into the Giveaway. The Sponsor, Promoter, and Administrator reserve the right to cancel if no eligible entries or claims for the prize are made. The Sponsor, Promoter, and Administrator reserve the right to cancel the giveaway at any time.
4. How to Enter.
 - a. NO PURCHASE NECESSARY TO ENTER. During the Entry Period, Entrants can enter the Giveaway by completing the following steps (the “Entrance Method”): (i) comment under a post identified by the Administrator on Instagram that directs entrants to comment under such post (the “Giveaway Post”), with such comment tagging another account that you would take with you to the AquArabia for a Getaway. The Entrant's comment is requested for engagement purposes only; it is not judged or scored, is not required to be correct, and has no bearing on an Entrant's chances of winning, which are determined solely by random draw. Entries made by an Entrant but not received or accepted by the Administrator are void, and the Administrator is not responsible for any entries not received or accepted. Any fraudulent interference with the entry process or attempt to breach these Official Rules may result in Entrant’s disqualification from the Giveaway in the sole discretion of the Administrator. (ii) the selected winner has 3 minutes to respond to a DM from the influencer to claim their prize.
 - b. Entrants can enter the Giveaway multiple times. Entry into the Giveaway does not constitute entry into any other giveaway sponsored by the Sponsor, promoted by the Promoter, or administered by the Administrator.

- c. By submitting an entry, you agree to be fully unconditionally bound by these Official Rules, and you represent and warrant that you meet the eligibility requirements. Those who do not follow all of the instructions or abide by these Official Rules or other instructions of the Administrator may be disqualified.
 - d. No automated entry devices and/or programs are permitted. Receipt of entries will not be acknowledged or returned. The Sponsor, Promoter, and Administrator are not responsible for late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed entries are eligible. Proof of submission of an entry will not be deemed to be proof of receipt by the Administrator.
5. Winner Selection. On July 18, 2026 between 15:00 PM and 19:00 PM UK time at the Administrator's regular place of business, the Administrator shall randomly select one (1) Entrant (a "Potential Winner") from all Entries received during the Entry Period, with the Potential Winner being subject to eligibility verification. The comment submitted by an Entrant is for engagement purposes only and does not affect an Entrant's chances of being selected; the Potential Winner is selected solely by random and fair draw. Once the Potential Winner has been selected he/she will be direct messaged on Instagram by @Henrycarmoores giving the Potential Winner 3 minutes to respond to the direct message. If the 3 minutes pass and the Potential Winner didn't respond, the prize will be reallocated. All decisions of the Administrator are final and binding with respect to all matters related to the Giveaway. A Potential Winner becomes a "Winner" when the Potential Winner complies with the terms outlined in Section 5 herein and otherwise complies with these Official Rules. Where the selected winner has not responded to the DM within the specified announcement period, the Sponsor, Promoter and Administrator reserve the right to hold another draw as outlined in Section 3.
6. Prizes. There will be one (1) prize offered for the Giveaway (the "Prize"). The Winner(s) will receive the following Prize: a 3-night getaway to Riyadh, AquArabia, inclusive of Economy class flights, on ground transportation. The Prize does not cover transport to and from the airport in the UK, Saudi Arabia E-Visa, Travel Insurance, and Food & Beverages during your stay in Riyadh, nor it won't cover any activities booked by the Winners, outside of the offered prize and as stated in section 6. The prize will cover the winner and their plus one. No Prize substitution shall be permitted except at the Administrator's discretion. The Prizes are nontransferable. The Prize shall be provided to the winner within 3

weeks of the Giveaway winner announcement. The total amount of the prize per 1 winner and their plus 1 shall not exceed SAR16,000. The booking of the getaway shall be organised by the Administrator.

7. Odds. The odds of winning depend on the number of eligible entries received during the Promotion Period for the Giveaway.
8. Winner Notification. The Potential Winners will be notified that they have been randomly selected as a Potential Winner of the Giveaway by Instagram direct message by @Henrycarmoores (the "Prize Notification"). As set out in the giveaway mechanics and rules, the selected winner has 3 minutes to respond to the direct message on Instagram. If the winner fails to respond within the set timeline, the Sponsor, Promoter, and the Administrator reserve the right to select another winner across the times and phases set out in section 5.
9. IT IS ENTRANT'S SOLE RESPONSIBILITY TO CONFIGURE ENTRANT'S ACCOUNT PRIVACY SETTINGS SO AS TO ACCEPT PRIVATE MESSAGES FROM THE ADMINISTRATOR OR A DESIGNEE OF THE ADMINISTRATOR. If any Potential Winner does not respond to Prize Notification within 3 minutes of the time of issuance (or such other timeframe as specified within the Prize Notification) or declines the prize for any reason, a disqualification will result, and the Prize will be forfeited.
10. Conditions and Releases By participating in the Giveaway, each Entrant and Winner agrees to release and hold harmless the Sponsor, Promoter, Administrator, each of their advertising and promotion agencies, and each of their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors (collectively, "Released Entities"), from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including property damage, personal injury and/or death which may occur in connection with, preparation for, travel to, or participation in the Giveaway, or possession, acceptance and/or use or misuse of prize or participation in any Giveaway-related activity and for any claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property-related cause of action. Entrants who do not comply with these Official Rules or who attempt to interfere with these Giveaway in any way shall be disqualified. The Sponsor, Promoter, and Administrator are not responsible if the Giveaway cannot take place or if any Prize cannot be awarded due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, pandemic, epidemic, weather.

11. General Terms.

- a. The decisions of the Administrator are final and binding on all matters relating to the Giveaway.
- b. Persons who tamper with or abuse any aspect of the Giveaway, attempt to undermine the legitimate operation of the Giveaway by cheating, deception, or other unfair playing practices, intend to annoy, abuse, threaten, or harass any other entrant or any representative of the Sponsor, Promoter, or Administrator, or who are in violation of these Official Rules, as solely determined by the Administrator, will be disqualified and all associated entries will be void. The Administrator shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Giveaway and to resolve all disputes in its sole discretion.
- c. Released Entities make no warranty, guaranty, or representation of any kind concerning any Prize (or any portion thereof) and disclaim any implied warranty.
- d. The Administrator reserves the right, in its sole discretion, to modify, suspend, extend, or cancel the Giveaway (or any portion thereof) if the Administrator is prevented from executing the Giveaway as contemplated herein by any event beyond the Administrator's control, including but not limited to: fire, flood, earthquake, explosion, pandemic or other public health crisis, labor dispute or strike, act of God or public enemy, network or equipment failure, riot or civil disturbance or war (declared or undeclared). The Administrator also reserves the right, in its sole discretion, to modify, suspend, extend, or cancel the Giveaway (or any portion thereof) should virus, bugs, unauthorized human intervention, or other causes or events corrupt administration, security, fairness, integrity, or proper operation of the Giveaway. In the event of cancellation, the Administrator may elect to identify the Winner and award the Prize by way of random drawing from among all non-suspect, eligible entries received up to the time of cancellation. The Administrator also reserves the right, in its sole discretion, to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Giveaway.
- e. Entries generated by a script, macro, or other mechanical or automated means will be disqualified. In the event of dispute as to the identity or eligibility of any Potential Winner based on an account, the winning entry will be declared made by the Authorized Account Holder of the applicable account used to enter the Giveaway, provided he/she is eligible according to these Official Rules. The

"Authorized Account Holder" is defined as the natural person who is assigned to the account by the applicable social media/streaming site.

- f. The Sponsor, Promoter, or Administrator's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- g. Any personal data provided by entrants will be processed securely and used solely for the administration of this giveaway and fulfillment of travel logistics in strict accordance with the UK GDPR and the Data Protection Act 2018.
- h. Privacy/Use of Data. The Administrator will be collecting personal data about entrants online, in accordance with its Privacy Policy found at <https://www.influencer.com/privacy>. By participating in the Giveaway, entrants hereby agree to the Administrator's collection and usage of their personal information and acknowledge that they have read and accepted the Administrator's Privacy Policy.
- i. No Implied Endorsement. The names of individuals, groups, companies, products and services mentioned herein, associated with the Sponsor, Promoter, or Administrator, or included on any prize, and any corresponding likenesses, logos and images thereof reproduced herein, have been used for identification purposes only and may be the copyrighted properties and trademarks of their respective owners. The mention of any individual, group or company, or the inclusion of a product or service as a Prize, does not imply any association with or endorsement by such individual, group or company or the manufacturer or distributor of such product or service and, except as otherwise indicated, no association or endorsement is intended or should be inferred.
- j. Intellectual Property. The trademarks, service marks and copyrights of the Sponsor, Promoter, and Administrator are proprietary to each respective party. All rights reserved.

12. Limitation of Liability and Governing Law.

- a. The Promoter, Sponsor and Administrator is not responsible for any flight delays, cancellations, itinerary alterations, or failures in resort operations caused by third-party suppliers, severe weather, or government travel restrictions.
- b. Travelers are required to respect the local laws, guidelines, and cultural customs of the Kingdom of Saudi Arabia. The Promoter accepts no liability for any incidents, entry denials, or legal issues arising from a failure to comply with local regulations.

- c. These Terms and Conditions are governed by the laws of England and Wales, and any disputes will be subject to the jurisdiction of the English courts.
- d. The Sponsor, Promoter, and Administrator make no representations or warranties of any kind, express or implied, regarding the Prize or Entrant's participation in the Giveaway. By participating in the Giveaway, Entrants agree to release, indemnify, defend, and hold harmless the Released Parties from and against any claim or cause of action arising out of participation in the Giveaway, including any breach of these Official Rules.
- e. Released Entities are not responsible for injury or damage to Entrant's or to any other person's computer and/or wireless device related to or resulting from participating in the Giveaway or downloading from and/or printing material downloaded from any websites associated with the Giveaway.
