I have provided source documents whenever possible, leaving out opinion pieces altogether, although there are some links that go to non-source sites, but that do provide direct links to source documents, and opinion is kept to a minimum. I'm doing this to save myself some time and energy as well as to save some space here. No "news" articles included, except in the cases where announcements of current events took place for proof that something took place.

This begins with some terms to know, since this is not given in the media or elsewhere, and they are important to know, so as to understand who the Gadiantons are and their plans.

A message consisting of a set of ten guidelines or principles is engraved on the Georgia Guidestones^[8] in eight different languages, one language on each face of the four large upright stones. Moving clockwise around the structure from due north, these languages are: [English](#), [Spanish](#), [Swahili](#), [Hindi](#), [Hebrew](#), [Arabic](#), [Traditional Chinese](#), and [Russian](#).

1. Maintain humanity under 500,000,000 in perpetual balance with nature. (That is a reduction of population of about 95% of humanity)
2. Guide reproduction wisely—improving fitness and diversity. (Eugenics)
3. Unite humanity with a living new language.
4. Rule passion—faith—tradition—and all things with tempered reason. (Faith and tradition are outdated – whose reason?)
5. Protect people and nations with fair laws and just courts. (This goes back to world courts and their authority top down, as opposed to jurisdictional authority. There is a lot of additional information I can point you to, but other points are more relevant)
6. Let all nations rule internally resolving external disputes in a world court.
7. Avoid petty laws and useless officials. (Sheriffs and police officers have been mentioned, among others. Systems of voting and the selection of said officials has also been discussed. It isn't Federalist, exactly, as it is on a global level with sectors, as opposed to nations. – I can provide these resources, but other points are more relevant)
8. Balance personal rights with social duties.
9. Prize truth—beauty—love—seeking harmony with the infinite.
10. Be not a cancer on the Earth—Leave room for nature—Leave room for nature.

2. What are Agenda 21 & Agenda 2030?

AGENDA 21 is the worldwide plan for sustainable development implemented at the local level through the city council, county and state. It is to be accomplished in the 21st century, and much of it has been implemented as of 2015. More soft-ball than A2030. I won't go into it much here.

Sustainable development, therefore, is a program of action for local and global economic reform – a program that has yet to be fully defined." AGENDA 2030 is the worldwide plan for sustainable development implemented at the national and worldwide levels. It can be described as global socialism/communism for the year 2030.

"COVID-19 has accelerated our transition into the age of the Fourth Industrial Revolution. We have to make sure that the new technologies in the digital, biological and physical world remain human-centred and serve society as a whole, providing everyone with fair access," he said.

"This global pandemic has also demonstrated again how interconnected we are. We have to restore a functioning system of smart global cooperation structured to address the challenges of the next 50 years. It should be noted that the UN Civil Society Conference was held in NYC from inception until 2008. After then, it has been held in influential/UN-aligned "pilot" cities. The conference was again held in NYC in 2015 and 2018. In 2019, it was held in Salt Lake. I bring this up because few other cities have sponsored the UNCSC worldwide, but the only other US city the UN has used to host this conference is SLC. (see below – highlighted text)

"In 2008 the conference reached a new level when it celebrated its first edition outside the United Nations Headquarters in New York. In celebration of the 60th Anniversary of the Universal Declaration of Human Rights, the 61st UN DPI/NGO Conference took place in Paris, France under the theme "Reaffirming Human Rights for All". The following year, the Conference was hosted by the City of Mexico, Mexico where the theme was "For Peace and Disarmament: Disarm Now!" In 2010 the Conference moved to Melbourne, Australia, where the discussion tackled the issue of global health, under the title: "Advance Global Health. Achieve the Millennium Development Goals." "Sister Sharon Eubank, First Counselor in the Relief Society General Presidency and director of LDS Charities, participated in the recent G20 Interfaith Forum in Buenos Aires, Argentina.

Eubank:

- "QUESTION 3: Can you identify three main challenges to women's full engagement in furthering the Agenda 2030 focusing on SDG 5 (gender equality), SDG 10 (reduced inequalities), and SDG 16 (peace, justice, and strong institutions)? What are the possible ways forward to overcome these challenges?"

Sister Eubank: "The challenge I choose to highlight is the assumption in policy circles that religion has nothing helpful to say about women because it is traditional, patriarchal, and the source of conflict. That is not only untrue, but it ignores the importance of religious faith to women themselves, 80 percent of whom identify with a religion and look to it for guidance. At the same time, religions can be actually held up in patriarchal constructs and practices.

Part of the look forward is in recognizing the importance of mobilizing women of faith to work on Sustainable Development Goals (SDG) issues and to acknowledge their faith not as a barrier but the key to progress and success. The 2030 agenda won't happen without religion, and religion won't happen without women. They are the movers.

The work would not be nearly where it is today without three women, and I want to pay tribute to them: Dr. Katherine Marshall, executive director of World Faiths' Development Dialogue (and I recommend her book Women, Religion, and Peacebuilding); Dr. Azza Karam, who chairs the UN Interagency taskforce on Religion and Development; and Jean Duff, a founder of the Partnership for Faith and Development. These fearless women have worked tirelessly for decades to ensure the faith voices of women are included at every level of development and that faiths open themselves to healthy and transformative practices that benefit women and their families.

The SDG {17 Sustainable Goals of Agenda 2030} goals on gender equality, peace, and justice are tackling how to change culture and behavior. Faith has a power greater than almost anything else to motivate people to act, to change minds, to alter behavior.

The way forward is to do just what this forum has as its goal. Invite and respect as many faith actors as possible, build understanding among them, and integrate them into every aspect of the 2030 SDG agenda. It will lead to the greatest success possible for equity, justice, and peace."

Bottom line is that is pretty low, and that is very misleading and also disappointing, given the sacrifice that the members make to give a tithe, and that they are kept out of the temple unless they give a full 10%.

8. Russell M. Nelson's Daughter and the Child Sex Ring:

I have studied Satanic ritual abuse, and some of this sounds like that is what it is. No justice will be served here, and that

is an absolute tragedy. I am not saying Nelson was involved, as nothing points to that, but the church was told this happened and they did not do much to keep these molesters from moving onto other children, and hurting them.

9. Relevant Quotes From Past Church Presidents and Others:

The Devolution of Utah into Wickedness:

This excerpt by Joseph F. Smith in 1870

- ❏ *“Instead of raising themselves to the standard of the Gospel, they are content to descend to the level of the wicked and corrupt. Many of the Elders of Israel who have responsibilities resting upon them, with which they will find they cannot trifle with impunity, are taking this course all the time. What wonder, then, that the Spirit of the Lord is grieved? What wonder that the Latter-day Saints need to be preached to continually? It is no wonder to me when I contemplate the condition of the people of these valleys, and especially Salt Lake City, Ogden, and our cities contiguous to the railways (Journal of Discourses, Vol.13, p.339 – p.340).”*

Here are the words of J. Golden Kimball, in a conference address in 1930, quoting his father spoken in 1868

- ❏ *“I claim not to be a prophet, but I am a son of a prophet, and I expect to give you evidence-whether you question the truth of it or not-that shall be left with you-that Heber C. Kimball was a prophet of God. President Brigham Young on more than one occasion said: ‘Heber is my prophet, and I love to hear him prophesy.’ In May, 1868-that is sixty-two years ago—he said: ‘**After a while the gentiles will gather in Salt Lake City by the thousands, and this will be among the wicked cities of the world.**’”*

Heber C. Kimball, in the Journal of Discourses, Vol.11, p.82 – p.83, had this to say on the subject in 1865:

- ❏ *“I do not say but that you are just as good men and women in this place as in any other place in the mountains; yea, I admit that the people are better in the country towns than in Great Salt Lake City, for the froth and scum of hell seem to concentrate there, and those who live in the City have to come in contact with it; and with persons who mingle with robbers, and liars, and thieves, and with whores and whore-masters, etc. Such wicked men will also introduce themselves into Davis County, and among all the settlements throughout these mountains; but where the people are truly righteous and just, wicked men can do them no harm; were the people all righteous who profess to be Latter-day Saints, they would constantly be on their watch against the encroachment of a wicked power. The wicked and corrupt who have settled in our community are taking a course to lead away those who are willing to be led away from the truth—those who have turned away from God; and it will be for our good, as a community, if such persons will leave and never again return to our Territory, unless they can do so with a determination to serve God and keep his commandments. I love those who love God; they are more precious to me than gold, and silver, or possessions.”*
-

- ② *"As the kingdom of God rises and advances upon the earth, so will the power of Satan increase to impede its progress until God shall purge that power from the earth, and so give the Saints the victory, that they can bear off his kingdom triumphantly in spite of the powers of Satan and wicked men. But so far as the power of Satan extends, just so far will be seen his operations to overthrow all righteousness. There is nothing that would so soon weaken my hope and discourage me as to see this people in full fellowship with the world, and receive no more persecution from them because they are one with them. In such an event, we might bid farewell to the Holy Priesthood with all its blessings, privileges and aids to exaltations, principalities and powers in the eternities of the Gods." (Brigham Young, JD 10:32, 8 April 1862)*
- ② *"When we see the time that we can willingly strike hands and have full fellowship with those who despise the Kingdom of God, know ye then that the Priesthood of the Son of God is out of your possession. Let us be careful how we make friends with and fellowship unrighteousness, lest the curse of God descends heavily upon us." (Brigham Young, JD 10:273, 6 October 1863)*
- ② *"When 'Mormonism' finds favor with the wicked in this land, it will have gone into the shade; but until the power of the Priesthood is gone, 'Mormonism' will never become popular with the wicked." (Brigham Young, JD 4:38, 31 August 1856)*
- ② *"And when the spirit of persecution, the spirit of hatred, of wrath, and malice ceases in the world against this people, it will be the time that this people have apostatized and joined hands with the wicked, and never until then; which I pray may never come." (Brigham Young, JD 4:326-327, 31 May 1857)*

Past Presidents of the Church and the UN:

**The text is a link* “Among the nations of the world today, there are precious few common bonds that could help overcome the clash of cross-purposes that inevitably must arise between groups with such divergent ethnic, linguistic, legal, religious, cultural, and political environments. To add fuel to the fire, the concept woven into all of the present-day proposals for world government (The U.N. foremost among these) is one of unlimited governmental power to impose by force a monolithic set of values and conduct on all groups and individuals whether they like it or not. Far from ensuring peace, such conditions can only enhance the chances of war.*

“In this connection it is interesting to point out that the late J. Reuben Clark, who was recently described as ‘probably the greatest authority on [the Constitution] during the past fifty years’ (American Opinion, April 1966, p. 113), in 1945 – the year the United Nations charter was adopted – made this prediction in his devastating and prophetic ‘cursory analysis’ of the United Nations Charter:

- ☐ *‘There seems no reason to doubt that such real approval as the Charter has among the people is based upon the belief that if the Charter is put into effect, wars will end... The Charter will not certainly end war. Some will ask – why not? In the first place, there is no provision in the Charter itself that contemplates ending war. It is true the Charter provides for force to bring peace, but such use of force is itself war... It is true the Charter is built to prepare for war, not to promote peace... The Charter is a war document, not a peace document.*

‘Not only does the Charter Organization not prevent future wars, but it makes it practically certain that we will have future wars, and as to such wars it takes from us the power to declare them, to choose the side on which we shall fight, to determine what forces and military equipment we shall use in the war, and to control and command our sons who do the fighting.’ (Source: Ezra Taft Benson. Address delivered on June 21, 1968, at the Farm Bureau Banquet in Preston, Idaho)

Covenants which would obligate our citizens to conform their social behavior, their educational practices to rules and regulations set down by international agencies? Such treaty obligations amount to the voluntary and piece-meal surrender of our political independence. The answer to all such questions is a resounding “no,” for the simple reason that the only way America can survive in this basically hostile and topsy-turvy world is to remain militarily, economically and politically strong and independent.*

"We must put off our rose-colored glasses, quit repeating those soothing but entirely false statements about world unity and brotherhood, and look to the world as it is, not as we would like it to become. Such an objective, and perhaps painful, survey leads to but one conclusion. We would be committing national suicide to surrender any of our independence, and chain ourselves to other nations in such a sick and turbulent world. President George Washington, in his immortal Farewell Address, explained our true policy in this regard:

'The great rule of conduct for us, in regard to foreign nations, is in extending our commercial relations to have with them as little political connection as possible... 'Tis our true policy to steer clear of permanent alliances with any portion of the foreign world... Taking care always to keep ourselves, by suitable establishments on a respectably defensive posture, we may safely trust to temporary alliances for extraordinary emergencies.'"

The Book of Mormon makes it very clear that in the latter days there are save two churches only--The Church of the Devil and the Church of the Lamb of God. It also makes it very clear as to what the church of the devil is and that it stands absolutely (100%) opposed to the Church of the Lamb of God (1Ne chapters 13-15).

38 O ye pollutions, ye hypocrites, ye teachers, who sell yourselves for that which will canker, why have ye polluted the holy church of God? Why are ye ashamed to take upon you the name of Christ? McConkie (1915–85) of the Quorum of the Twelve Apostles defined the great and abominable church: “The titles church of the devil and great and abominable church are used to identify all ... organizations of whatever name or nature—whether political, philosophical, educational, economic, social, fraternal, civic, or religious—which are designed to take men on a course that leads away from God and his laws and thus from salvation in the kingdom of God” (Mormon Doctrine, 2nd ed. [1966], 137–38).

“Jeremiah 23; D&C 64:39 The Lord reveals to Jeremiah that in the last days, those who would call themselves the Lord’s prophets would be leading his people astray. Not little pockets of his people - all of his people. This idea is highlighted in D&C 64:39. It’s important to note that throughout Jeremiah 23, the Lord says “my prophets” and “the shepherds/pastors of my people.” This means it is/will be those who were supposed to be the Lord’s prophets but weren’t actually.

For those who think this could mean outsiders coming in and trying to pretend to be the Lord's prophets - that interpretation does not match the context given by Jeremiah. - Isaiah 1:23-24; 3:12-15; 9:14-16; 28:7-8,14-16; 29:9-10; 56:9-12; 1 Ne. 21:1

Isaiah sees the religious leaders of the Lord's people leading them astray in the last days and acting in evil ways. Cited verses above are the most direct references but there are additional indirect references. Their wickedness is largely what necessitates the coming of the Servant to destroy them and free God's people. Note that the same context that is laid out in Jeremiah 23 applies throughout Isaiah's accusations against the religious leaders. He's pointing specifically at those who are in the positions of leadership over the Lord's people. - JST Matthew 21:53-56 Jesus reveals the future destiny of the Latter Day Saints in a nutshell. Saying that his vineyard will be overseen by miserable, wicked husbandmen and that he will destroy them and the church membership as a whole and give the leadership of his people to other husbandmen who are righteous.

Note that this further illustrates, and more expressly so, what Jeremiah and Isaiah were pointing at. - D&C 84:19-27, 57-58 The Lord reveals to the saints in 1832 a type for what will happen to them if they remain under condemnation for not entering into the terrestrial order of the gospel (aka the fullness of the gospel) by offering up a broken heart and contrite spirit which is the New Covenant spoken of (v.57). The result would be a curse by way of a demotion to the telestial order of the gospel (aka the preparatory gospel) and loss of Christ's name and higher priesthood. - 3 Ne. 27:7-12; Mosiah 27:13 The Lord declares that his church must have his name and be built upon his gospel. Then he states to the end times and insinuates that the church will be run by the devil and by men instead of by him, and that they "have joy in their works for a season," but that "by and by the end cometh" and that they would be hewn down.

The Lord declares that there is one way for his church to be overthrown - from iniquity within. - D&C 101:43-62 "The Parable of the Redemption of Zion" The Lord reveals in more detail just how the miserable wicked men would overtake his vineyard as described in JST Matt. 21, reinforcing the notion that his people would fall into apostasy shortly after the restoration, and that he would a portion of those same servants back a second time to reclaim his people/vineyard and avenge him of his enemies.

Those who would listen and be called out are referred to as "the strength of mine house." The parable ends with the servant asking the Lord when all these things will be accomplished - the Lord says "when I will." This refers to how the servant, who the Lord would name shortly, did not understand when all of this would happen, and that the Lord deemed it wise to not tell him. These events would be fulfilled when the servants all came back a second time. - D&C 103:1-22;

He names Joseph Smith as the servant who is called to gather those servants together and be the man raised up as Moses to lead his latter day people out of bondage. - Jacob 5:49-end A different look at the same prophecy from the "Parable of the Redemption of Zion" just mentioned. The Lord sends his servant to attempt to restore his people to the truth (vv.50-59). He points out that he's leaving the bad branches for now."

Isaiah 3:

9The expression of their faces testifies against them, And they [i]display their sin like Sodom; They do not even conceal it. Woe to [j]them! For they have done evil to themselves.

10Say to the righteous that it will go well for them, For they will eat the fruit of their actions.

11Woe to the wicked! It will go badly for him, For [k]what he deserves will be done to him.

12My people! Their oppressors treat them violently, And women rule over them. My people! Those who guide you lead you astray And confuse the direction of your paths. Mormon 4:5 But, behold, the judgments of God will overtake the wicked; and it is by the wicked that the wicked are punished; for it is the wicked that stir up the hearts of the children of men unto bloodshed.
