Deposit & Reservation of Puppy

1. Buyer will pay Seller a \$500.00 USD refundable deposit to reserve the above-mentioned puppy or a spot with the litter.
2. Puppies are chosen in order deposit is received (first deposit gets first pick, second deposit gets second pick, etc).
3. Seller reserves the right to first and second picks of litter to be kept as a future breeding dog.
4. Seller reserves the right to refuse service to anyone. If the Buyer has paid a deposit to reserve a puppy, all conditions and warranties listed in this Contract will be null and void upon refund of the deposit.
5. Should the Buyer change their mind or decide not to purchase a puppy, the deposit is refunded.
6. Seller will not guarantee color or gender.

Health Guarantee

The Seller guarantees this puppy to be of sound health and temperament at the time of the sale. The Seller will provide a health record of all shots, worming, and a veterinarian exam. For this health guarantee to be valid, the Buyer agrees to take this puppy to a licensed veterinarian of their choice within 72 business hours. **A copy of the veterinarian's exam must be sent back to us.** Failure to have the puppy examined by a vet within three days of the puppy's delivery/pickup date, or if the Buyer fails to provide required immunizations and medical treatment, will void this health guarantee.

1. The Seller guarantees your puppy for a full year to be free from a congenital/genetic disease that is life-threatening/crippling. If there is such a defect, it must be diagnosed in writing by a qualified veterinarian. The Seller will refund the Buyer the purchase price less the deposit.
2. If a refund is given, the dog must be returned to the Seller unless a death occurs.
3. In the case of a death, the Buyer must provide the Seller with proof of an autopsy. The autopsy will be performed at the Buyer's expense to determine the cause of death.
4. If the puppy is sold or given away, this health guarantee becomes void.
5. Buyer agrees to maintain the puppy in good health, provide routine preventative health care, including, but not limited to, vaccinations, heartworm prevention, flea and tick control, regular baths, grooming, and any other preventative medication a vet feels is needed. Veterinary records must be provided to the Seller if requesting refund. If any of the above preventative care has not been provided, the health guarantee becomes void.
6. Unless prior arrangements have been made, our puppies are sold on a non-breeding contract. Buyer agrees to spay or neuter this dog by 12 (twelve) months of age. Buyer

must send proof to Seller via email or regular mail. Upon execution of this contract, Buyer agrees the puppy will not be used for breeding unless prior arrangements have been made.

Lifetime Commitment

1. If at any time Buyer can no longer retain possession of the puppy, the puppy can be returned to the Seller with their veterinarian records and all paperwork issued for the dog. Seller is always willing to take the dog back at no cost to Seller at any time in the puppy's life.
2. The seller also requires that the buyer follow the full intent of Washington State RCW 46.61.660 regarding the safe transport of dogs in a vehicle. RCW 46.61.660 states that no animal can be transported on the outside of a vehicle (like a truck bed) unless it is in a suitable harness, cage, or enclosure to prevent falling or being thrown.

Purchase Price

Buyer is making a \$500.00 deposit and has a final balance due to the Seller upon release of the dog to the Buyer.

The buyer will forfeit the pick-of-litter order if payment is not made in full by the expected release date(8 weeks after the date of birth or after a well-vet check can be completed). After that time, the Seller may sell the puppy to another party.

Prices: The \$500.00 deposit goes towards the total price of the puppy.

Payment Options

Final payment must be made in cash or cashier's check (certified check), no exceptions.

Statement of Agreement

In order to validate this contract, the contract must be fully completed and signed by the Buyer of the puppy described above, as well as signed by the Seller, and delivered to the Seller prior to the puppy leaving the Seller's premises. Buyer will receive a copy of this contract for their records.
