Dear Honorable Senator/Congressman

I am writing to you because your help is needed to stop a dangerous measure before the New Mexico Legislature with far reaching implications—namely the suspension of the US Constitution. —

HJR4 is a resolution related to the 2023 Water Security Planning Act (SB337). While this act aims to create a framework for regional water planning and protection of water rights, there are several areas of concern that may have long-lasting impacts on our state's water security.

HJR 4 appears to do several things:

- 1. Redefine the Law of The Land, which could supercede the US constitution as redefined in this proposal
- 2. Transfer ownership of lands and natural resources to the state (full stop, minus justification given).
- 3. Creates an entitlement, granted by the state, as opposed to an inherent and private right of ownership
- 4. Perhaps most dangerous centralizes complete control of lands, air, water, and natural resources to the state for determinations of land use, zoning, and actual ownership ("trustee" aka management services.)
- 5. Pre-empt current trustees and title deeds "for the collective good."

HJR 4 proposes an amendment to the NM State Constitution that could potentially redefine the "Law of the Land" and transfer ownership of lands and natural resources to the state.

One of the key concerns is that the Interstate Stream Commission would be authorized to make loans and grants for regional water. This could potentially result in the misallocation of resources and insufficient oversight.

Additionally, the act does not clearly define the role of regional water planning entities which could lead to confusion and inconsistency in water planning across regions.

The act also does not adequately address the protection of water rights for Indian nations, tribes, and pueblos.

The proposed changes could be seen as a shift from private/individual ownership to state/government ownership, potentially diminishing the power of the people.
