## MIT Mystery Hunt 2020 – Regulations Regarding the Presence and Participation of Minors

For our purposes, minors are defined as individuals who are not MIT students and are younger than 18 years of age.

All team captains must be aware of the requirements surrounding the presence and participation of minors, regardless of whether or not there are minors on their team.

Team captains are responsible for helping their team members understand and comply with these policies.

Team captains are considered to be de facto volunteers for the MIT Mystery Hunt and are be required to read, and agree to abide by, the MIT Code of Conduct for Working with Minors that outlines their responsibilities to the minors on their teams before the start of the Hunt. This agreement will be indicated through the MIT Mystery Hunt 2020 Health & Safety Quiz.

Team captains are asked to relay to the parents and legal guardians of any minors on their teams the following information:

- Minors may participate in the hunt remotely without restriction.
- Minors on campus must be supervised by their parent or legal guardian at all times, unless hunting as part of an official school group. If hunting as part of an official school group, minors must be accompanied by a number of chaperones that is dictated by the ages of the participating minors. The student-to-chaperone ratios are:

| Student Age Range | Student-to-Chaperone ratio |
|-------------------|----------------------------|
| 5 years & younger | 6:1                        |
| 6–8 years         | 8:1                        |
| 9–14 years        | 10:1                       |
| 15–17 years       | 12:1                       |

Minors must travel to and from campus in the care of their parent/legal

- guardian/school group.
- Minors may not be present on campus overnight specifically between 1:00 AM and 6:00 AM.
- You must receive a signed <u>liability waiver</u> for each minor attending or participating on campus. The waiver must be signed by the minor's parent or legal guardian in advance of the minor's arrival on campus. Signed forms can be emailed to team captains.
- We will be adding all parents/legal guardians to the MIT Alert system for the weekend. Please submit one emergency contact per minor via this <u>Emergency</u> <u>Contact for Minors form</u> before January 12, 2020.
- We will provide emergency contact information on business-sized cards. We would
  like these cards to be distributed to minors and ask that they carry them with them at
  all times while they are on campus.
- By entering the MIT Mystery Hunt 2020 competition, all of your team members who
  will be on the MIT premises consent to be photographed, filmed, and/or otherwise
  recorded (collectively, the "Recordings"). Your entry and their participation on
  premises constitutes irrevocable consent for MIT (including MIT Mystery Hunt
  volunteers) to make such Recordings for any purposes related to the promotion or
  presentation of the MIT Mystery Hunt program.
