- **Substitute Teacher Daily Rate for 2022-23**
 - At SCASD: Current 105/day; 20+ days goes up to 120/day
 - Proposed increase to subbing for teachers 125/day; subbing for paraprofessionals and teaching assistants 110/day for upcoming school year
 - Kat moved to accept, Crescent seconded; Approved unanimously
