



Legislation proposed by Ron Paul related to **social security** in just the past *2 years*:

### H.R. 219: Social Security Preservation Act -

To invest the annual surplus of such trust funds in marketable interest-bearing obligations of the United States to protect such trust funds from the public debt limit.

#### H.R. 150: Senior Citizens Tax Elimination Act

Exclude gross income from social security benefits from taxation.

## H.R. 147: Prescription Drug Affordability Act

Allow prescription drugs to be bought from foreign countries. (Such as Canada where prescriptions are far cheaper)

#### H.R. 151: Seniors' Health Care Freedom Act

Declares that no persons otherwise eligible for old-age benefits under Social Security shall be denied such benefits because of their voluntary refusal to participate in any part of the Medicare program.

#### The Federal Reserve and how it hurts Seniors

The **Federal Reserve** (the Fed) is a **PRIVATE BANK** that prints money with very little to no government oversight. As a population grows, in order to keep the value of your money the same, new money needs to be printed.

- 1. If too little money is printed the cost of goods goes down because your money is worth more (deflation).
- 2. If too much money is printed, the cost of goods goes up because your money is worth less (inflation).


The reason a loaf of bread no longer costs 25 cents and now costs \$2.50 is because the Fed is printing too much money. And when the Fed prints 5 trillion dollars like they have over the past 3 years, expect that loaf of bread to cost a lot more! You still get your full check, but you can't buy anything with it!

Take the following for example: A gallon of gas in 2011 on average costs \$3.43. A gallon of gas in 1913 was around 10 cents. In 1913, dimes were 90% silver. The silver content from a dime minted in 1913 is worth about \$3.00 today. You can almost buy a gallon of gas today with a dime from 1913!

The silver content can buy roughly the same amount as it did 100 years ago while the paper dollar has been devalued 2000% to 3000% intentionally by printing more money!



In the following graph 2000 = 2000% inflation, so something costs 19x what it did in 1913!

<u>David Asman</u>: Hold on. Before you go any further let me just ask, because a lot of people would say, "Wait a minute, 20 billion dollar payout, that doesn't sound like much of a benefit for BP." How does that benefit BP to have this fund?

Ron Paul: Well, they have to pay, everybody knows that, and I think they know that, too. So they might as well concede to this. But I don't think BP is being a good example of the free enterprise system. You know, I think that they're very much in tune with big government, and here the process is sort of suspicious. Under what law have they done this? There's not even an executive order, not even a congressional approval, and here they're dealing with 20 billion dollars. I think they should pay 100 billion dollars if there are 100 billion dollars worth of damage.

## Fixing the economy

Ron Paul believes that to fix the economy the following things need to be done:

- Liquidate the country's debt. With huge government and personal debt, people just do not have the money to purchase new goods.
- 2. Cut government spending. Ron Paul released a plan that will cut 1 Trillion from the budget in the first year and balance the budget within three!
  - a. Restore confidence in the American Dollar. Investors and businesses are afraid of investing in America. By balancing the budget confidence in the value of the Dollar will return.
  - b. Cut taxes and put more money back into the economy. By cutting the size of government, taxes can be cut. The smaller the government gets, the more taxes can be cut. Ron Paul is in favor of shrinking the government to the point where income tax is zero percent!
  - c. Cut five government departments. Most things that the government does, a private entity can do better.
- 3. Help businesses. Ron Paul supports companies bringing their money back to the United States. The USA is number 10 on the most business friendly nations!
  - Reducing the corporate tax rate. He plans to reduce the corporate tax rate from 35% down to 15%
  - b. Reducing regulations on companies. He will cut harmful government regulations on companies. This is detailed more on the "Government Knows Best" page.



#### Government knows best?

Politicians make legislation on business all of the time and there are always unintended and unforeseen consequences.

The following list contains some prominent examples of government placing restrictions on businesses that you may be able to relate to:


<u>Community Reinvestment Act</u>: This act and subsequent changes forced banks to make loans to people who could not pay for them. This contributed to the housing collapse of 2008.

<u>"Durbin Amendment"</u>: This legislation that passed just recently forces a cap on debit fees banks place on businesses. Because of this, Bank of America and many other banks are adding fees for Debit Cards to make up for this lost income.

NAFTA (North American Free Trade Agreement): NAFTA is the world's largest free trade area. The agreement between Canada, the U.S. and Mexico links 439 million people and produces \$15.3 trillion in goods and services annually. Critics say that the agreement has led to a **net loss of 879,000 jobs in the U.S**., and a decline in labor protection and degradation of the environment in Mexico.

## Is Ron Paul's military stance crazy?

Ron Paul raised more money from active duty military and veterans in the second and third quarter than all of the other candidates combined, including Obama!

- 4. We do not participate in nation building and expansion of empire.


Fact: The United States has not formally declared war since World War II. This means that all wars since World War II have been illegal and in direct opposition to the U.S. Constitution.

## Does our current foreign policy make us safer?

### Afghanistan 1973-74

Roger Morris, writing in the Asia Times, argued that as early as 1973-74, the CIA began offering covert backing to radical Islamist rebels in Afghanistan premised on the claim that the authoritarian government headed by Mohammed Daoud Khan might prove a likely instrument of Soviet military aggression in South Asia.

#### Afghanistan 1978-1980s

One of the CIA's longest and most expensive covert operations was the supplying of billions of dollars in arms to the Afghan Mujahideen

militants. The CIA provided assistance to the fundamentalist insurgents through the Pakistani secret services, Inter-Services Intelligence (ISI), in a program called Operation Cyclone. Somewhere between \$2–\$20 billion in U.S. funds were funneled into the country to train and equip troops with weapons. With US and other funding, the ISI armed and trained over 100,000 insurgents. The early foundations of al-Qaida were built in part on relationships and weaponry that came from the billions of dollars in U.S. support for the Afghan mujahidin during the war to expel Soviet forces from that country. The initial bombing of the World Trade Center in 1993, the attacks on the U.S. embassies in Kenya and Tanzania, the attack on the USS Cole, and the attacks of September 11 were all allegedly linked to individuals and groups that at one time were armed and trained by the United States and/or its allies.

#### Iran 1953

In 1953, the CIA worked with the United Kingdom to overthrow the democratically elected government of Iran led by Prime Minister Mohammad Mossadegh who had attempted to nationalize Iran's petroleum industry, threatening the profits of the Anglo-Iranian Oil Company.

Declassified CIA documents show that Britain was fearful of Iran's plans to nationalize its oil industry and pressed the U.S. to mount a joint operation to depose the prime minister and install a puppet regime.

## Iran 2001-present

President Bush secretly authorized the CIA to undertake black operations against Iran in an effort to topple the Iranian government. The Black Ops include a U.S. propaganda and disinformation

campaign intended to destabilize the government, and disrupting the Iranian economy by manipulating the country's currency and its international financial transactions.[139] The United States began to target Iran and several other Muslim countries for regime change starting at least in 2001.

#### **Iraq 1963**

In February 1963, the United States backed a coup against the government of Iraq headed by General Abd al-Karim Qasim, who five years earlier had deposed the Western-allied Iraqi monarchy. Iraq 1968 In 1968, the CIA allegedly backed the coup by Ahmed Hassan al-Bakr of the Baath Party, bringing Saddam Hussein to the threshold of power.

### Iraq 1973-75

The CIA colludes with the Shah of Iran to finance and arm Kurdish rebels in an attempt to overthrow al-Bakr. When Iran and Iraq sign a peace treaty in 1975, the support ceases. The Shah denies the Kurds refuge in Iran, even as many are slaughtered. The American betrayal of the Kurds was investigated by the Pike Committee, which described it as cynical and self-serving.[56] It has been argued that it tarnished America's image with one of the most pro-Western groups in the Middle East.

#### Iraq 1992-1995

According to former U.S. intelligence officials interviewed by The New York Times, the CIA orchestrated a bomb and sabotage campaign between 1992 and 1995 in Iraq via one of the insurgent organizations, the Iraqi National Accord, led by Iyad Allawi. According to the Iraqi government at the time, and former CIA officer Robert Baer, the

bombing campaign against Baghdad included both government and civilian targets.

#### Somalia 2006-2007

Although the United States has had an ongoing interest in Somalia for decades, in early 2006 the CIA began a program of funding a coalition of anti-Islamic warlords.[135] This involved the support of CIA case workers operating out of the Nairobi, Kenya office funneling payments of hundreds of thousands of dollars to the Alliance for the Restoration of Peace and Counter-Terrorism. As the power balance shifted towards this alliance, the CIA program backfired and the militias of the Islamic Court Union (ICU) gained control of the country.

In late December 2006 a United States-trained[137] and funded Ethiopian military force attacked militias of the ICU in a series of battles known as the War in Somalia.

## Will Ron Paul legalize drugs?

Drug legalization is a state issue, not a federal issue. If a state decides a drug should be illegal then they should be the ones to make that decision.

Personally he believes that a person should be able to do whatever they want with their own body so long as they do not harm another individual.

## Did prohibition of alcohol work and make the country a better place?

Rather than reducing crime it seemed prohibition had transformed the cities into battlegrounds between opposing bootlegging gangs. In a study of over 30 major U.S cities during the prohibition years of 1920 and 1921, the number of crimes increased by 24%. Additionally, theft and burglaries increased by 9%, homicide by 12.7%, assaults and battery rose by 13%, drug addiction by 44.6% and police department costs rose by 11.4%.
