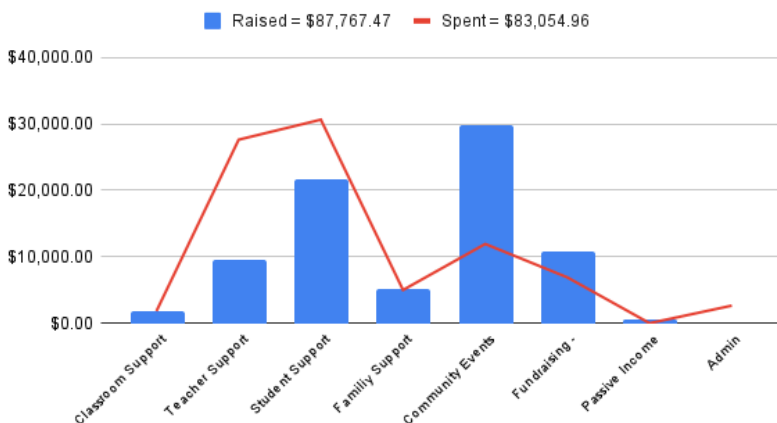


Minutes for CES PTA Meeting, May 28, 2024
