- International Christian Worker (ICW) families receive lower tuition rates because their organizations support GIS and our non-Thai staff (who donate their salaries back to Grace).
- Payment of annual tuition in full by the due date will net a 1,000-baht discount per family.
- Payment of tuition quarterly will attract a 500-baht installment fee per quarter per family.

Discount	25% off Grades 6-8 ICW Tuition rounded to nearest 500 baht

Gold

ADDITIONAL FEES

First-Year Students

English Proficiency Test Fee 1,500 baht (if required)

Standardized Testing Fee 1,500 baht

Application Fee 2,000 baht

Entrance Fee 35,000 baht (if admitted)

These nonrefundable fees must be paid for each child applying to GIS.

Returning Students

Re-enrollment Fee 10,000 baht

This nonrefundable fee is due every year by 15 January in addition to tuition.

All Students

Capitalization Fee 15,000 baht

This nonrefundable fee for campus development is due 15 August (or January if enrolling Sem 2).

Multiple Child Discount

The first 3 children pay full tuition. Each additional sibling receives a 20% discount off tuition only.

School Lunch Program

Thai and Western options, including a daily salad bar. The price per semester is as follows:

Grades K-2 4,400 baht / semester

Grades 3-5 5,000 baht / semester

Grades 6-12 7,200 baht / semester

New students may try a week for free. Parents may pay by day at reception to join their children.

Tuition and Fee Payment Options

Methods of Payment

For security, GIS prefers to receive payment by direct deposit or credit card. Cash payments should be made by an adult. If your organization pays on your behalf, the finance office will invoice your organization upon request.

The tuition for each family will be paid according to one of the following schedules:

1. **Annual Plan**

- Due by 15 August 2025
- A **1,000-baht discount** will be applied for payment of annual tuition in full by the due date

2. **Semester Plan**

The annual tuition shall be divided into two (2) equal payments due at the beginning of each semester:

- Semester 1: 15 August 2025
- Semester 2: 15 January 2026

3. **Quarterly Plan**

The annual tuition shall be divided into four (4) equal payments due on the first day of each quarter:

- Quarter 1: 15 August 2025
- Quarter 2: 15 October 2025
- Quarter 3: 15 January 2026
- Quarter 4: 15 March 2026
- A **500-baht installment fee per quarter** will be assessed if the quarterly tuition plan is selected

*For all plans, the **capitalization fee** is due by 15 August 2025 and the **re-enrollment fee** is due by 15 January 2026.

Student Visa

To obtain a student visa, **the capitalization fee and tuition must be paid in full for the entire year.**

Late Fees

Accounts will be **automatically assessed 1.5% interest per month** (prorated by day) on all past-due tuition and fees according to the invoice. If payment cannot be made by the due date, please contact the chief financial officer (CFO) at finance@gisthailand.org as soon as possible to discuss the situation and sign a Late Payment Agreement.

Delinquent Accounts

Parents with past-due accounts will be asked to make payment arrangements so their children can continue at GIS.

Other Policies

- If a student attends class for any part of an academic quarter, tuition will be assessed for the entire quarter.
- Parents must email registrar@gisthailand.org and submit a Withdrawal Form prior to receiving a tuition refund.
- A student who does not attend GIS for any part of two consecutive school years will need to reapply and will be processed as a new student for tuition and fees.
