Roll Call (above): Acceptance of Minutes: Mr. Warnero moved, and Mr. Tripp seconded to accept the minutes from May 8, 2024. New Business: Track Update – Officially started yesterday and unofficially stated it will be completed by August 20, 2024. Mr. Galella sent out a One-Call to inform our school community that the track and elementary playground are off limits and will notify once upgrades are complete. Mr. Tripp also stated they have posted signs in both areas as well. Elementary Playground Update -Mr. Galella informed the committee this was started last week, Mr. Tripp stated RHL is onsite completing groundwork, company installing equipment wants to put in before the gravel & turf are installed, they have been notified and then RHL will come back to finish gravel and Turf. Feasibility Study Update – Mr. Tripp informed the committee the company did come in and start the architectural walk through and we have been sending them facility prints, they need cafeteria information and Mr. Galella sent out dates for Bronson to meet with each building administrator for their respective areas. Mr. Galella wonders what the study will show, especially with the basement area and Dave's garage area. 2 nd SRO (?Any New Grants) – Visibility in SCCTC and Elementary areas. Mr. Galella stated Dr. Puza was added to eGrants to be able to look and help complete grants that may come available to fund this. Old Business: Monthly walk-through - reminder Safety Drills - Don't need to complete, no students in June 2024. Other Items: A. Any concerns from committee members. Worker's Compensation yearly invoice. The insurance company depending on claims either gives a credit or charge. SCCTC was good and received over a \$2,000 credit towards the bill, where Elk Lake had a couple big claimants and received an additional charge over \$10,000. Mr. Gazzillo asked about the incidents with vehicle between the gym and track area, what more could be done with Stop signs and signs, could something be painted on the pavement to assist. Mr. Warnero also asked about repainting in front of the high school bus parking and coming down from the parking lot, etc., Mr. Tripp asked to please send an email with all of those spots to make sure they are all completed.
