2. Use single spacing on A4-sized paper.
3. Cross-check several times to eliminate errors, superfluous material and repetition.
4. Use figures and tables sparingly; plan their format to use page space economically.
5. Put figures and tables at the proper position in the text.
6. All pages should be numbered consecutively not less than 10 pages and not more than 15 pages.

7. The equality, the main body of the paper should be numbered in consecutive order a:

- I. INTRODUCTION
- II. METHOD
- III. RESULTS AND DISCUSSION
- IV. CONCLUSION

All pages should be numbered consecutively not less than 10 pages and not more than 15 pages. Tables and Figure should be titled and numbered consecutively in Arabic numerals and placed on separate sheets at the end of the manuscript.

Please submit MS-Word file as completed manuscripts (camera-ready manuscripts) including the diagrams and photographs. The proceedings will be printed in black only. Keep it in mind when the use of color is unavoidable.

The full paper should be written in English.

A. Page Setup

All script should be typed on A4-sized (210mm x 297mm) white paper, with 1,15 spaced. Keep proper margins such as left (2 cm), top (2 cm), right and down (2 cm). Article must be typed justified formation and first paragraph has to be dragged 0.75 cm to the right side. Greece symbol has to be original like β (*beta*), γ (*gamma*) and etc. Chemical notation has to go with standard rule, such as BaTiO_3 and Mg(OH)_2 .

B. Font

Use the "Times New Roman" font with the size of 12 pt for the body text, abstract and reference; size 11 for author's name, corresponding author email and author's affiliation; and size 12 or 10 for tables and figures (must be consistent).

C. The Title

Avoid titles that are too long (maximum 16 Word); the titles should be in capitals for all words including for conjunctive (see the example).

D. The Name(s) of The Author(s)

Write complete author's name without academic degrees.

E. Affiliation

Add affiliation description for all authors and the affiliations are cited by superscripts as shown in the above example. Add an asterisk to the corresponding author and denote his/ her e-mail address in the affiliation descriptions (footnote).

F. The Abstract

The abstract should present the outline and main points of the paper and give the principal conclusions. It should be a single paragraph of no more than 200 words. Abstract should be written using "Times New Roman" font with the size of 12-pt. Abstract body should be presented in English. Add Keywords not more 10 words after the abstract.

G. Headings

Four ranks of heading may be used chapter, section, subsection, and sub-subsection. Use the heading styles: 1. Chapter, 1.1 Section, and (1) Subsection and (a) Sub-subsection. Put a space line before each heading. Put a single space line after only the chapter headings.

H. Paragraphs

Please put a single space line between paragraphs

I. INTRODUCTION

An Introduction, Authors should state the objectives of the work at the end of the introduction section. Before the objective, Authors should provide an adequate background, and very short literature survey in order to record the existing solutions/method, to show which is the best of previous researches, to show the main limitation of the previous researches, to show what do you hope to achieve (to solve the limitation), and to show the scientific merit or novelties of the paper. Avoid a detailed literature survey or a summary of the results. Do not describe the literature survey as author by author, but should be presented as a group per method or topic reviewed which refers to some kinds of literature.(Bays et al., 2021)




Figure 1. Example figure

II. METHOD

A. Numerals

Numerals of five or more digits are grouped in three-digit blocks by spaces, e.g. 12,345 (if written in English) or 12.345 (if written in Bahasa Indonesia).

- 1) Pay attention a significant figure and avoid an unnecessary long digit number.

B. Units

Use SI unit or SI derived units.

C. Mathematics

Extreme care should be taken in preparing mathematical typescripts. All mathematics

should be legible, precise and carefully aligned. The following shows an example of putting an equation in the text:

$$y = A + Bx + Cx^2 \quad (1)$$

where y and x are the output and input variables, respectively; A and B are constants.

Italic character should be used as variable. On the other hands, the “Times New Roman” character should be used as function e.g. sin, exp, log.

As in above, equations should be at the left-hand margin; while the equation number displayed expressions with Arabic numerals in parenthesis should be at the right-hand margin. Put space lines both before and after the equation(s).

III. RESULT AND DISCUSSION

Figures, photographs and tables should appear at proper places in the text (Figure 1). The width of figures, photographs and tables should be full width.(Ciarambino et al., 2020; Klin et al., 2019).




Figure 2. Put the caption for figure 1 here. Use an appropriate and as clear as possible caption for the figure. Make sure the end of sentence without period

For references to them belonging to the paper, use, e.g. Figure 2 and Table 4. The captions are put under that for figure and the photograph and put on that for the table (please see the example).

Every text citation must be listed under the heading “References” centered at the end of the text. APA sixth edition format is selected as the reference to write the citations used in the paper. In conducting citations, it is mandatory to use Mendeley or Zotero. Referencing is written using Times New Roman 12. The following is the example of how to write the references.
