The board meeting of the HLV Community School District was held on July 12, 2023, at 8:05am. President Doran called the meeting to order.

Roll call resulted in board members Doran, Kolesar, Blomme, Kupka, and Henning being present, a quorum was declared. Also present were Superintendent Hohensee, Lori McClenathan and Carol Healey.

Blomme motioned to approve the Hometown Current as the official publication for 2023-2024, seconded by Henning, unanimously adopted.

Blomme motioned to approve Victor State Bank \$1,000,000, Keystone Savings Bank \$6,000,000 and Green State Bank \$3,000,000 as the official depositories for the 2023-2024 year.

Motion by Kupka, seconded by Kolesar, approved appointing Ahlers Cooney as the school attorney for the 2023-2024 year.
