Any data is not stored anywhere and not shared with anyone.

3. How We Use Collected Information:

- a. Barcode Scanning for Billing: The camera access is utilized exclusively for scanning barcodes on products. This information is processed within the app to generate accurate invoices and streamline the billing experience for users.
- b. Bluetooth Printing: The location access is used solely to establish a Bluetooth connection with nearby thermal printers, enabling users to print bills and receipts directly from the app.

4. Data Security:

a. Local Processing: Any data obtained through barcode scanning is processed locally within Ayurbill-Azhakiyamandapam and is not transmitted or stored externally. It remains within the app and device for the sole purpose of enhancing the billing functionality.

b. Security Measures: We employ industry-standard security measures to protect data accessed via the camera and location services. This includes encryption and secure handling practices to ensure the safety of any scanned barcode information or location data used for Bluetooth printing.

5. Third-Party Access:

a. No External Sharing: Ayurbill-Azhakiyamandapam does not share, sell, or transfer any barcode, camera-generated data, or location data to third parties. Camera access and location access are strictly confined within the app's functionalities and are not shared externally.

6. User Control and Consent:

a. Permission Prompt: Users are requested to grant access to their device's camera to enable barcode scanning within the app. Users are also requested to grant access to their device's location solely for the purpose of enabling Bluetooth connectivity with nearby thermal printers. Users maintain the option to grant or deny these accesses, respecting their control over privacy settings.
