

END-USER LICENSE AGREEMENT FOR PALLETSTACKING SOFTWARE IMPORTANT
PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT
CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: PalletStacking
Solutions End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and PalletStacking Solutions. for the PalletStacking Solutions software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and PalletStacking Solutions, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

1. GRANT OF LICENSE.

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use.

PalletStacking Solutions grants you the right to install and use copies of the SOFTWARE PRODUCT on your computer running a validly licensed copy of the operating system for which the SOFTWARE PRODUCT was designed [e.g., Windows 95, Windows NT, Windows 98, Windows 2000, Windows 2003, Windows XP, Windows ME, Windows Vista].

(b) Code for activation.

PALLETSTACKING send a copy of the license code, which must not be subjected to reverse engineer, or illegal manipulation or transfer the license code to another computer, user or company without proper authorization from PALLETSTACKING. PalletStacking completing their trade obligation once have submitted or distributed the activation code on the license purchased.

(c) Backup Copies.
