REPEM ("we", "our", or "us") operates the REPEM mobile application (the "App"). This Privacy Policy explains how we handle information when you use our App.

1. Information We Collect

At this time, **REPEM does not collect, store, or process any personal data from users.**

We do **not** collect:

- Name
- Email address
- Phone number
- Location data
- Payment information
- Device identifiers
- Usage analytics
- Cookies or tracking data

Users can use REPEM **without creating an account and without providing any personal information.**

2. How We Use Information

Since we do not collect any personal data, **no user information is used, shared, or processed** in any manner.

3. Third-Party Services

REPEM does **not** use any third-party services that collect user data, including but not limited to:

- Analytics tools
- Advertising networks
- Payment processors
- Tracking SDKs

If third-party services are added in the future, this Privacy Policy will be updated accordingly.
