CHANGE ORDER: A change order can include multiple changes to the components of a building. With the limitation of one change to the building's dimensions per change order. (length or width or height)

Service/Product Provided

An HCW Estimation System Packet, in pdf form, will be provided upon each submission and includes the following:

5. Stock Purlin Order Sheet.
6. Custom Purlin Order Sheet.
7. Panels, Trim, Components, Accessories Order Sheet.
8. Building Sheet Proposal.
