INTRODUCTION (Times New Roman 12 Bold)

At the beginning of each paragraph, it is straight and between paragraphs with 6 spaces (see template). Written on A4 format paper with the introduction of 400-800 words, Times New Roman 12pt, 1.15 spaces. Sentences are composed in a passive form, without mentioning the author's name, as well as other pronouns, such as "we" or "I". Numbers ranging from 1 to 10 as a measure of quantity, must be typed in narrative form (words), except for the numbers for Tables and Figures. For example six days (not 6 days).

The introduction contains state-of-the-art explaining the existence of research problems that need to be answered through research activities. This section explains the theories within the scope of the research, existing phenomena, as well as the gap between the theories and the facts. This section also outlines the theories explaining the relationship among researched variables, relevant research results, and hypothesis. The relationships between current and previous research, as well as contribution to modern science, are also explained. Finally, this section is closed with the statement of problems/research objectives, and the novelty of the research.

RESEARCH METHODS (Spacing 1.15, between paragraphs 6pt)

This section outlines briefly the research subject and object, variable operationalization, population and samples, the sampling method, and the statistical test applied in the research. The total content of the research method is around 300 - 600 words

A paper for publication in Journal must contain a title, names and affiliations of the authors, a list of keywords, a brief abstract at the beginning, a conclusion section at the end of the main body, and a list of references that follows the conclusion section. The manuscript must be typewritten with single spacing and wide margins, on a single side of an A4 paper. The text should be in two-column format. Times New Roman typeface should be used throughout. A manuscript will not be accepted for review.

Each page of subtitles should be bold (without a title number) starting with a title page to facilitate review.

Title and Names (Subsection, Times new roman 12 Bold). The title of the paper should be typed in boldface and centred on the page. The authors' names should also be centred on the page. Directly under the authors' names, place their affiliation(s), with a full postal address and email address for each author, centred on the page. We also ask to add ORCID iDs or Google Scholar iDs, unique codes that identify the individual(s) who contributed to research.

All citations in Theoretical Review must-have reference source (name, year), except conclusion made by the author. All cited references have to be listed in Bibliography. Cited references minimum 60 percent from journals. Those journals were published a maximum of ten years old.

Headings. It is useful and recommended to divide the full text into paragraphs (or sections), with titles assigned with serial Arabic numbers and typed in the capital all significant first letters, centred, as in Sample Manuscript.

The first paragraph is usually, but not obligatory, denoted as 1. Introduction, but the last becomes a rule entitled Conclusion. The last paragraph (section) reflects the findings of the author, in the form of a set of concise sentences numbered sequentially by Arabic numbers.

Nomenclature and units. Follow internationally accepted rules and conventions: use the international system of units (SI). If other quantities are mentioned, give their equivalent in SI or if SI units do not exist, in an internationally accepted unit.

Definition of social entrepreneurship. The scholarly articles about SE began to be discovered easily after the 2000s. Further, **Table 1** summarizes the influence of each construct in the model of PSE. Firstly the SESE construct directly affected PSE by 9.16% while the SEPS contract affects PSE by 23.99%. The SESE represents the self-efficacy in running social entrepreneurship. Generally, the majority of students own some obstacles related to self-confidence in creating a new venture. Indeed, students require high self-efficacy in starting a social enterprise. Cause of the reason, this behaviour makes a lower impact on the self-efficacy to the intention. Tables. Be sparing in the use of tables and ensure that the data presented in tables do not duplicate results described elsewhere in the article (e.g. in graphs). Tables should be numbered consecutively following their appearance in the text and given a suitable caption. Tables should be simple with brief column headlines (including all units) and a few rows and columns as possible. Each table should be numbered consecutively and referred to in the text (e.g. Table 1). Supplied tables on separate pages at the end of the manuscript.

The article must contain at least 10 reference sources (60 percent from accredited national/international journals and 40 percent from other sources), using Times New Roman 11pt, single-spaced, and 6 pt between each reference. References are typed left aligned, based on the alphabetical order of the author's name, without distinguishing between books, journals, and online journals.
