- 1.Mrs. VanMeter welcomed everyone to the meeting.
- 2.Mrs. VanMeter shared a Fiscal Office update. Our Tax Budget for FY2024 has been approved by the Wayne County Budget Commission. We were able to roll our bond millage back from 4.7 mills to 4.1 mills for this year.
- 3. Our financial audit for Fiscal Year 2022 has been completed by Rea & Associates of Millersburg. The audit report is available on the Auditor of State's website.
- 4. Bus Purchase We will be receiving \$46,881 this year from ODE to replace one of our route buses.
- 5. Facilities Update Mr. Frank gave a short facilities update which included some information about the bus garage on Summit Street.
- 6. Ohio School Plan Cyber Grant. Our school insurance is through Ohio School Plan and they are offering Ohio Schools grants that can be used for firewall installation/upgrades, system backups, Hardware upgrades, email filters, and MFA implementation. Our technology director and I completed the requirements and we've been awarded \$2465.00 to spend on qualified upgrades.
- 7. GovDeals To date we've collected \$5,912 since September. Some of the things we've been able to sell include: an old bandsaw, rubber mats from the weight room, old weight rack and bench, 4 outdated AED's, and chromebooks that were end of life.
- 8. Levy Discussion a worksheet was shared with the committee outlining the current levies for Green Local along with options for renewal. A short discussion took place amongst committee members.

Levy Worksheet

Possible scenarios to decrease voter fatigue:

- A. A combination renewal levy would be keyed off of the \$500,000, as the first levy expiring, and thus could be on the primary election in 2025, the the general election in 2025, then any election in 2026. This levy would be for a maximum of a 10 year period of time.
- B. A substitute levy to take the place of either of both emergency levies could be on at any election before expiration of the emergency levy(ies). A substitute levy is allowed to be a reduced amount, but could not increase the total dollar amount substituted. This levy could be for a period of time or continual.
- C. Or we could leave the levy cycle as is and have an issue on the ballot in 2025, 2027, and 2030

- 1.Mrs. VanMeter welcomed everyone to the meeting and there was a brief round of introductions.
- 2. The mission/vision along with the committee charter was briefly reviewed with a focus on how the committee ties in with the district's strategic plan and the importance of using the committee as an avenue to improve public awareness of the district's financial status.
- 3. Mrs. VanMeter gave an update regarding the following spring and summer projects of the district and current financial issues.
  - A. Curriculum New math curriculum from K-5th grade was purchased with grant funds. Updates to the high school science lab occurred over the summer. A \$10,000 donation from a local business helped to defray the cost of the science lab upgrade,
  - B. Weight room Campaign New flooring, doors and weight machines were installed over the summer. Community donations paid for 75% of the project, a total of \$63,984 has been raised for the weight room to date,
  - C. Berkey Field House The Berkey got a small facelift over the summer. Asbestos was removed from the ceiling of the lobby and part of the board office. All outside doors were replaced along with all of the windows. This project was paid for with federal grant dollars.

- D. Bus Garage Last fall the district was able to purchase the bus garage we'd been leasing from the Keith family. The district took ownership of the facility located on Summit Street last October. A second location in Marshallville housed 4 buses. The Marshallville location owned by the district was sold at auction September 1st. The auction brought in \$66,000 and the proceeds from the sale will be used to make some needed updates to the Summit Street garage and all buses will be housed at the Summit Street location moving forward.
- E. New Hires Mrs. VanMeter shared with the committee some facts about the Tri-county Educational Service Center in Wooster and how the ESC supports our district. This led to an update about the district's classroom aides.
- F. School Lunches An update was given to the committee regarding the school lunch program. The last two school years all of the district's students were able to eat breakfast and lunch for free. Low-income families will one again have to apply for free or reduced-price meals. At the September board of education meeting Mrs. VaMeter shared with board members exactly how this change in policy will affect our cafeteria fund this year.
- G. GovDeals GovDeals online marketplace provides services to government, educational, and related entities for the sale of surplus assets to the public. Thousands of items are sold in a variety of categories including transportation, heavy equipment, industrial and manufacturing equipment. Green Local recently set up an account and plan on placing some items on the website to dispose of them. The first item listed, a bandsaw, sold for \$175, bidding had started at \$50.

Using text messages from the school regarding fiscal information, (somewhat like the daily covid text) to relay important information. The text could could include links to newsletter articles or information on the treasurer's website

Pulling possible performance indicators found in the CUPP report and sharing those on the website

Sharing how the board decides on capital projects (ie: what criteria the board uses and how many students are served by various projects)

talked specifically about wanting to know more regarding our expenses related to maintenance, payroll, transportation, and new projects. (How much are we spending on utilities from year to year)

Explaining the "why" surrounding district financial decisions to create more community support

Calculating a "days of Operation" chart showing the amount of days the district can operate using our current cash balance.

Collectively the committee made a decision to look at the Cupp Report at the next meeting and decide which items would be helpful to share on the district website. Mrs. VanMeter will bring a copy of the CUPP report for members to review.

# Green Local Schools Business and Finance Committee Minutes Thursday, April 8, 2021 at 7 p.m.

1. Ms. Markland welcomed everyone and asked that the committee table or carry forward to the next meeting the District Strategic Planning listed under Old Business, due to this meeting being for informational school finance purposes.

- 2. Ms. Markland shared a slide presentation with information on school finance, explaining that a school district's fiscal year is from July 1 to June 30. A school district's 5 year forecast is approved in November after the election takes place and updated in May of the following year. Ms. Markland provided a general overview of the 5 year forecast, including the fact that it includes operating monies of the school district, it does not include state and federal grants, and the importance of its accuracy. She highlighted the various revenue and expenditure line items for the committee.
- 3. Mr. Frank and Mr. Davis provided information on House Bill 1, which is the Fair School Funding initiative. The current school funding formula has consistently been declared unconstitutional. Green Local is struggling to support House Bill 1, as it currently stands due to losing \$300,000 per year in funding. The State price tag for House Bill 1 is a \$2 billion increase. Mr. Davis shared that the new formula is based on the amount actually needed to educate a student, as well as a teacher/student ratio, with monies following the student. There is potential for it to be implemented in July 2021.
- 4. Ms. Markland highlighted sources of district revenues, as well as a breakdown of district expenditures. Mr. Frank provided specifics on the school district's open enrollment revenues, explaining a bar graph of open enrolled students in/out and the net revenues amounts. Mr. Frank shared information about class sizes and teacher certification changes at the middle school. Ms. Markland indicated that if a school district has a large number of open enrolled-in students, but then has to hire more teachers, open enrollment becomes a losing situation.
- 5. Ms. Markland and Mr. Frank shared celebrations in terms of district finances over the past several years including the Wayne County Community Foundation grant which has provided for pianos; a sampling of many items purchased on behalf of the district from other sources, shifting expenditures away from the general (operating) fund; Bureau of Workers' Compensation grants to be used for the purchase a forklift and a Berkey door project; the establishment of a SALT fund with \$10,000 of seed money that has grown to \$30,000 with potential over the next 15 years to increase to \$1 million; a bond refunding saving approximately \$510,000 in debt payments, to name a few. It was mentioned that the revenue streams and savings examples discussed are not all-inclusive but a good model for a proactive approach in improving the school district's bottom line.
- 6. There was discussion concerning leadership turnover and the importance of retention and consistency. Mr. Meech shared that he has worked under 9 principals in 26 years and stressed the value of staff stability. It was mentioned the district definitely has consistency in its teaching staff.

Mr. Brillhart shared how the Charter was developed, stating that when the committee comes up with a proposal for the treasurer, the treasurer may take the proposal to the board. The treasurer is charged with oversight and governance of the committee, setting the agenda and taking the lead for committee actions. This committee will assist the treasurer in better serving the board.

Mr. Frank explained that at the meeting the two board members will report at the next board meeting, but at the meeting they are committee members. They are not here on behalf of the board, etc.

4. Mr. Frank highlighted the District Strategic Plan on the website and reviewed its content. Focus Area 4 is Business and Finances. Mr. Frank mentioned that we want to do it better than anyone else. Mr. Frank talked about the Mission Statement, the 5 "We Believes" and the "We Wills".

The Committee will develop the goals, strategies, and actions. Mr. Davis mentioned that the goals and action steps will change but long-term, we will continuously be setting new goals.

5. Discussion about the development of goals and strategies.

It was mentioned that it would be helpful to know how the district receives revenue and how communication is being handled to provide suggestions on how to improve.

A strategy example may be in educating the community on how the district receives funding. Currently this is being shared on the website and in the newsletter. Board meeting minutes are on the district website and include the monthly Financial Report inclusive of a check register of expenditures.

A question was asked if the district can track user activity on the website.

Discussion was made about the district newsletter such as what age group is reading it and ideas were provided of how the younger generation wants to receive information.

Newsletter reports the amount spent per student but how are the students doing academically compared to other districts.

What are the district's current financial reserves?

What are the district's immediate and long term needs?
