課程說明

本課程以偏差行為與社會控制為主題，選取以各類不同偏差行為為案例的研究（包括街頭暴力、露宿公共空間、參與幫派、因精神狀況衍生的行為、物質濫用、），介紹各種討論偏差行為的社會學取徑（包括張力與失序論、標籤論、情緒趨力論、次文化、差異連結等），進而討論如何主流社會以迥異手段予以控制（如司法、警政、教育、宗教、文化、醫療等）。第一部分以介紹不同取徑及行為為主，第二部分以呈現不同社會控制方式為主，第三部分則討論偏差與其他重要社會學的理論分析範疇之間的交織關係，例如性、性別、種族、南北。選擇的讀物因授課老師的偏好與專長，多為使用民族誌或其他質性方法的作品，同學可自行搜尋數量龐大的量化犯罪學相關文獻以為補充。由於這是研究所的討論課，老師將不會有系統講演犯罪學重要的研究取徑的內涵，有需要了解的同學可參考侯崇文著《犯罪學：社會學探討》(台北:三民書局)或Inderbitzin et al. (2017) Deviance and Social Control (New York: Sage)。
