A Manhattan urologist who was accused of sexually abusing a high-school intern has been hit with new comparable allegations by 4 male former sufferers, courtroom papers present. NewYork-Presbyterian/Weill Cornell is a defendant within the fits; Northwell is named in one. After appointments, PADUCH sent certain victims — including minor victims — text messages from his private cellphone.
