Meeting opened with prayer at 5:15 PM.

Motion by Mary R. to approve the minutes of the previous meeting (7/29/21).

Second by Jim H. All in favor.

Review of the Balance Sheet, Income Statement, and Check register:

- FY22 1st Qtr - Motion by Jim H to approve the financial documents. Seconded by Mary R and all were in favor of the motion.
- FY22 2nd Qtr - Motion by Mary R. to approve the financial documents without the Investment Pool reports. Seconded by Laura D. and all were in favor of the motion.

1. Investment Pool reports – Reports for the 2nd Qtr were not received and were not reflected in the 2nd qtr financial statements. Will update when IP reports are received.

1. Employee Retention Credit (ERC)
 - a. Received a check for \$8,654.44 in August. Shared by SH/SA/HN.
 - b. Credit of payroll taxes for 2020 (outside of PPP loan) and Q1 & Q2 of 2021 thru the CARES Act.
2. UPCSA weekend was Sept 25/26
 - a. Goals: SH \$16,612 SA \$12,632 HN \$4,163
 - b. Pledges: SH \$17,165 SA \$17,260 HN \$3,595
3. 2020-21 Black & Indian Grant – 2nd half of funds received in July.
 - a. SH – Awarded \$6000 to go towards evangelization costs.

- b. SA – Awarded \$5000 to go towards evangelization costs, including centennial celebration.
 - c. HN -Awarded \$4000 to go towards evangelization costs, including more BB Prayer Houses, replica of a longhouse
 - d. Will allocate some of the funds to subsidize Music Director salary.
 - e. 2nd half of 2021 request re-submitted. B&I Mission changing to calendar year.
4. LOF grant for 2021-22 – \$2,127 received in August
- a. Applications submitted under Sacred Heart Church (to be shared)
 - b. \$1500 for “Word on Fire ENGAGE” subscription
 - c. \$400 for One Bread/One Body publication
 - d. \$250 for distribution of M. Kelly book

Old Business:

- Convent house renovations completed. (siding, etc.) \$7,460.76. Building funds are low. Expense was paid out of the Checking account.

New Business:

- Needed Rectory and Schoolhouse repairs were discussed. Some rectory roof tiles are missing but roof is not leaking. Look into repairing in the spring.
- Schoolhouse steps need to be repaired. Wayne mentioned that the furnace in the schoolhouse appears that it needs maintenance before using.
- Floor in the church near the candles is weak. Nick L is checking.
