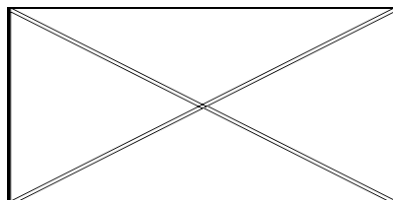


Figure 1. This is a figure. Figures should be placed in the main text near to the first time they are cited.
