## 1. Seller Information

## 2. General

These terms and conditions apply to all purchases from ReMakeAble. By placing an order, the customer accepts these terms.

ReMakeAble is a small business that develops and supplies custom parts and reproductions, often in low volumes.

---

## 3. Products

Products may include:

- Reproduced parts
- Improved designs
- Prototype or low-volume production

Products are typically not OEM parts. Minor variations in finish, material, or tolerances may occur.

## 4. Orders and Agreement

Orders are placed via:



- Website (order request)
- Email communication

An order becomes binding only when:

- It is confirmed by ReMakeAble
  - Payment or deposit has been received
- 

## 5. Pricing

All prices are listed in NOK (or other currency for export).

Prices may vary depending on:

- Quantity
- Complexity
- Manufacturing method

Shipping, customs, and any applicable taxes are additional.

## 6. Payment

Payment may be made via:

- Vipps
- Invoice
- Other agreed methods

For custom production, ReMakeAble may require:

- Full or partial prepayment

Production normally starts once payment is received, unless otherwise agreed.

---

## 7. Delivery

Delivery time varies and is typically:

- 2–8 weeks for small batches
- Longer for custom projects

Delays may occur. Customers will be informed of significant changes.



Risk transfers to the customer once the product has been delivered.

---

## 8. Right of Withdrawal

The right of withdrawal does not apply to:

- Custom-made products
- Products manufactured according to customer specifications

This is in accordance with Norwegian Consumer Protection legislation.

For standard products, withdrawal rights apply as per applicable law.

## 9. Claims and Warranty

Customers must report defects within a reasonable time.

Claims do not cover:

- Normal wear and tear
- Incorrect use or installation

If a claim is approved, ReMakeAble may:

- Repair
  - Replace
  - Or refund the product
- 

## 10. Liability

Products are used at the customer's own risk.

ReMakeAble is not liable for:

- Indirect damages
- Consequential losses

The customer is responsible for correct installation and use.

## 11. Intellectual Property

Designs developed by ReMakeAble remain the property of ReMakeAble.

Customers may not copy, reproduce, or commercially manufacture designs without written agreement.

## 12. Privacy

Customer information is used only for:

- Order handling
- Customer communication

Data is not shared with third parties without consent.

## 13. Disputes

Disputes should be resolved amicably where possible.

If no agreement is reached, the case may be brought before Norwegian consumer authorities or courts.
