In past MMC's there were creations ranging from avatar creators, social worlds, games, generative art, custom tools and much more. Free entry. Anyone can participate. Individual or groups allowed.

# How is the donation used?

**Before Prize Donation Deadline:** January 30, 2024 1:00AM EST (UTC 06:00)

- 50% Prize Pool
- 50% Operational Costs

**After Prize Donation Deadline**

- 100% Operational Costs

**Prizes will be given out in USD or the winner's home country currency.**

Fifty percent of donations before the **prize donation deadline** are added to the Prize Pool. This Prize Pool is awarded to MMC participants at the end of the event. Any donation meant for the Prize Pool must be sent before January 30, 2024 1:00AM EST (UTC 06:00) Tuesday, in order for a sponsor to receive sponsorship benefits. The Prize Pool's size influences which categories will be included and the specific monetary value of prizes awarded to winners.

MMC requires a lot of time and effort to create an event everyone can enjoy. Operational costs for the MMC include legal, accounting, and employee compensation. All donations received after the Prize Pool donation deadline will go to Creator Jam operational costs. The deadline to donate to the MMC is March 24, 2024 1:00AM EST (UTC 06:00) Sunday.
