### When can HfLAs new fiscal sponsor start accepting donations

Currently it looks like the accepting of donations stops on April 30th and the end of the fiscal sponsorship happens on June 30th. That leaves a gap of 2 months where HfLA cannot accept donations. Can HfLAs new fiscal sponsor start accepting donations on HfLAs behalf starting May 1st. It would not do any disbursement to HfLA until it was HfLAs fiscal sponsor.
